Contents of the data file</b>	When the shareholder registers for the Annual Shareholders' Meeting the following personal data will be collected: <ul style="list-style-type: none"> <li>• name</li> <li>• personal ID</li> <li>• telephone number</li> <li>• name of a possible accompanying assistant or proxy representative and the personal ID of the proxy representative</li> </ul> The person in charge of the file enters the above specified personal details of the participants in the system maintained by Euroclear Finland Ltd.
<b>6. Regular sources of data</b>	The system compares the personal ID provided with the data in Aspo Plc's shareholder register maintained by Euroclear Finland Ltd, and selects the ownership information of the shareholder registering from the shareholder register.
<b>7. Regular disclosure of data and the transfer of data outside the EU or the EEA</b>	Not disclosed.
<b>8. Principles of data security</b>	A. Manual data: The data is stored in locked premises and is available only for eligible persons. B. Electronically stored data: The data is subject to restricted access protected by user ID and password.
