The **Industrial Commission of Arizona** has updated the *Physician's Fee Schedule*. The schedule went into effect Oct. 1.

### California

The **Department of Industrial Relations** announced the following California fee schedule updates that went into effect Oct. 1:

- › *Physician and Non-Physician Services Fee Schedules*
- › *Outpatient and Ambulatory Surgery Center Fee Schedules*

In other DIR news, department officials announced the **Medical Treatment Utilization Schedule (MTUS) Drug List** *has been updated* and went into effect Oct. 1.

### Maine

The **Workers' Compensation Board** has updated its *Inpatient Facility Fee Schedule*. The schedule went into effect Oct. 1.

### Minnesota

The following **Minnesota Department of Labor and Industry** fee schedules have been updated and are effective Oct. 1:
