The [Documentation Type](#) allows the user to easily select documents such as Intake, Treatment Plan, Progress Plan, and more.

User-defined [Reminders](#) can be sent to specific people under treatment for any number of reasons.



[Outcome Measures](#) is a powerful management tool in determining an overall view of the client’s condition, from admission to discharge. Medication compliance, 12-Step Involvement, relapse prevention are included in Outcome Measures.

The system’s [Diagnostic and Statistical Management \(DSM\)](#) includes extensive information on Axis-I to Axis-V diagnoses. Axis-V contains the person’s [GAF](#) score.

The **Mental Status Exam (MSE)** is comprised of sections on the patient's psychiatric history, appearance, memory, mood, concentration, sleep, appetite, thought form, sensory / cognitive orientation, etc., helping to create a Psychiatric Formulation.

Medical Assessment compiles information on the person's medical history and current status helping to arrive at the treatment plan.

The **Comprehensive Intake Assessment** is a multi-dimensional assessment instrument based upon Integral Psychology.

Appointment Scheduler identifies appointment types such as Depression, Group Therapy, Individual Therapy, Psychiatric Evaluation, Initial Assessment and more, including user-defined appointment types.
