A powerful **demographics database** is created with the system having a number of built-in safety checks (1) For identifying possible duplicates *as they are entered*. (2) For ensuring the exact person being searched is **correctly identified**. (3) with **role-based security** based on login giving users the ability to access / edit only the information to which they have been given access by the Administrator.

It all starts with Scheduling

"Scheduler" is a misnomer when referring to the appointment scheduler in MedicsPremier since it really is a powerful management, financial and workflow tool for any BH practice.

- Schedule physicians, psychologists, clinicians, and therapists with **user-defined appointment types and reasons**
- Easily schedule groups for therapy sessions
- Display appointments in a variety of **user-defined, color coded views**



- **Messages / alerts** relative to the appointment and / or person can be displayed
- **Authorizations and eligibility** for hundreds of commercial payers as well as Medicare and Medicaid can be **batch-processed** through the scheduler. Appointments requiring attention are clearly "red flagged" displaying corrective actions needed prior to practice or patient prior to the appointment

- **Co-payments and balances** due by single or multiple guarantors are viewable through the scheduler
- The scheduler can manage **workflow** throughout the facility helping to **eliminate bottlenecks while maximizing productivity**
- Alerts are issued on **missed appointments**
- Access a library of **user-defined scheduler-related reports** can be compiled on an as-needed basis, or be set to automatically compile multiple times daily or on pre-determined days / times
- The scheduler can produce its own **appointment reminders and recalls**, and / or be integrated with **automated communication systems** which can be used for a number of other reasons such as information about the practice, inclement weather alerts, new medications available for specific patient groups, etc.

With a **99% success rate on first-time claims** as reported by Emdeon™ for claims submitted through systems from ADS, the **ICD-10 compliant** MedicsPremier for BH helps ensure maximized reimbursements on submitted claims.

But an extraordinary success rate on claims is only one way MedicsPremier for BH helps capture revenue. There's more:

- Both **UB-04 and HCFA** EDI / billing for inpatient and outpatient facilities
- EDI can be processed for **additional medical specialties** for practices / facilities requiring that capability. Other specialties might include **internal medicine, neurology, and pain management**.
- Includes built-in **census reporting and billing**
- **Automatic billing at time of discharge** for inpatient facilities
- ICD-10: The system contains the built-in **Medics ICD-10 Code Converter** for easy conversion of BH ICD-9 codes to the correct ICD-10 codes. ICD-9 coding will continue to be available in tandem with ICD-10 for reference, and for any payers who might still require ICD-9 codes even after the ICD-10 deadline date.
- **Authorization tracking** and inbound / outbound **referral tracking**
- **Eligibility verification** typically takes a few seconds to perform, ensuring people with appointments are pre-authorized. Any payer issues / pre-certifications required are displayed which can be relayed to patients for reconciliation prior to their appointments.
- Tracks **numbers of allowable visits** to help ensure authorizations are obtained when needed
- **Payroll reporting** for 1099 employees



- Displays **co-payments** and **balances due** in advance through the Scheduler , and on arrival.
- Invoke a variety of **dashboards** displaying meaningful representations of **EDI, financial and management data and analytics**.
- **The no-cost Vision™ Claim Tracking capability** through Emdeon clearly displays the practice's pending claims as they appear in the payers' queues along with their status, all in real time. - Use the system's built-in **statement generator** or download statement data to Expressbill™ for **effortless, cost-effective offsite statement production and fulfillment**. Either way, MedicsPremier tracks statement history.



- Expressbill can also generate secure, **interactive e-statements** to the person's preferred email address. e-statements also contain a **"Pay Now"** button for secure, online payments.

- Accurate, **automated reconciliation** (payment posting) of payers' EOBs for payers and guarantor amounts.
- Focus on what should be paid now with intelligent and productive **A/R and collections management** for payers and patients. Use a comprehensive set of tools and collection agency-level capabilities to help keep receivables and days outstanding to a minimum.
