

CARRIERS NEEDED: DEFENSE FREIGHT TRANSPORTATION SERVICES (DFTS)



► What is DFTS?

The Defense Freight Transportation Services (DFTS) contract is a 7-year transportation contract that will service the Defense Logistics Agency (DLA), Defense Contract Management Agency (DCMA), and their 17,000 plus vendors located nationwide. The United States Transportation Command (USTRANSCOM), an agency under the Department of Defense (DoD), awarded Crowley Logistics one of the largest surface transportation contracts in the Continental United States. Crowley is expected to move over 400,000 shipments within the first year of the contract.

General FAK such as MRE's, water, uniforms, vehicles and other military supplies to support the warfighter. The current DFTS contract does not include Arms, Ammunition, and Explosives (AA&E) or Transportation Protective Services (TPS).

INSTALLATION ACCESS REQUIREMENTS

All drivers must speak English. Installations conduct background checks and vehicle inspections. The time from the gate to dock will vary by installation. The DoD is currently working on standardizing installation access through the Electronic Physical Access Control Systems (ePACS) which will reduce wait times at the gate.

PAYMENT TERMS


48 hours from POD acceptance. Fee for payment is variable and based on current prime interest rate.


Less Than Truckload
