

2018 GOODWILL IN-STORE TICKET SWEEPSTAKES
OFFICIAL RULES

**NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE.

1. HOW TO ENTER: You can enter the 2018 Goodwill Ticket Sweepstakes ("Sweepstakes") on October 20, 2018 from 12:00 PM – 2:00 PM Central Time ("CT") by going to the Goodwill Store & Donation Center located at 8615 W. Woodward Ave, Woodridge, IL 60517 ("Goodwill Store").

Alternate Method of Entry ("AMOE"): To enter the Sweepstakes without going to the Goodwill Store, you may enter by mail as follows: On a 3" x 5" card, legibly handprint or type your first name, last name, email address, zip code, telephone number (including area code), date of birth (including birth year), and mail your 3" x 5" card in a business size envelope to: 2018 Goodwill Ticket Sweepstakes Entry, Attn: Rachel Chessky, Halas Hall, 1920 Football Drive, Lake Forest, IL 60045.

All AMOE entries must be postmarked by October 19, 2018 and received by October 20, 2018. Limit one (1) entry per envelope. Each envelope is considered one (1) entry into the Sweepstakes. Multiple entries submitted or completed by anyone other than the Entrant are void. No mechanical reproductions will be accepted. AMOE entries must contain all entry fields to be entered, otherwise void.

Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different addresses, and /or any other methods will void that Entrant's entries and that Entrant may be disqualified from the Sweepstakes. Entries submitted by anyone other than the Entrant are void. Neither the Chicago Bears, the Sponsor, nor Independent Administrator will verify receipt of entries for Entrants. All entries submitted become the sole property of Sponsor and will not be returned. Sponsor is not responsible for lost, late, misdirected, illegible, damaged or postage-due mailed entries.
