## **Eligibility**

Visit one (1) of the forty-one (41) Chicagoland Goodwill locations ("Goodwill Store") on Saturday, July 28, 2018 and Sunday, July 29, 2018 and locate one of ten (10) coded Mini Orange Stress Footballs per location (410 mini orange stress footballs total). Bring the coded mini orange stress football to the check-out register (purchasing the mini orange stress football is not required) and receive an official Chicago Bears Sideline Cap and an opportunity to enter the Sweepstakes. Complete an official entry form and other required paperwork to officially enter the Sweepstakes. One entry per person.

## **Selection of Winners**
