

**2019 GOODWILL VIP AUTOGRAPH ZONE AT CHICAGO BEARS TRAINING CAMP**  
**SWEEPSTAKES**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE.  
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. HOW TO ENTER:** You can enter the 2019 Goodwill VIP Autograph Zone at Chicago Bears Training Camp Sweepstakes (“Sweepstakes”) between July 26, 2019 to August 10, 2019 by going to the Goodwill Store & Donation Center located at 455 Main St. NW Bourbonnais, IL 60914 (“Goodwill Store”).

**Alternate Method of Entry (“AMOE”):** To enter the Sweepstakes without going to the Goodwill Store, you may enter by mail as follows: On a 3" x 5" card, legibly handprint or type your first name, last name, email address, zip code, telephone number (including area code), date of birth (including birth year), and mail your 3" x 5" card in a business size envelope to: 2019 Goodwill VIP Autograph Zone at Chicago Bears Training Camp Sweepstakes- Entry, Attn: Rachel Chessky, Halas Hall, 1920 Football Drive, Lake Forest, IL 60045.

All AMOE entries must be postmarked by August 5, 2019 and received by August 9, 2019. Limit one (1) entry per envelope. Each envelope is considered one (1) entry into the Sweepstakes. Multiple entries submitted or completed by anyone other than the Entrant are void. No mechanical reproductions will be accepted. AMOE entries must contain all entry fields to be entered, otherwise void.

Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different addresses, and /or any other methods will void that Entrant’s entries and that Entrant may be disqualified from the Sweepstakes. Entries submitted by anyone other than the Entrant are void. Neither the Chicago Bears nor the Sponsor will verify receipt of entries for Entrants. All entries submitted become the sole property of Sponsor and will not be returned. Sponsor is not responsible for lost, late, misdirected, illegible, damaged or postage-due mailed entries.

**2. ELIGIBILITY:** The Sweepstakes is open to all legal residents of the United States ages 18 years and over as of July 26, 2019, unless prohibited in the state. Employees, officers, directors, agents, and representatives of Goodwill Industries International, Inc. (“Sponsor”), The Chicago Bears Football Club, Inc. (“Chicago Bears”) the National Football League, and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, advertising and promotion agencies, and their immediate family members (mother, father, sister, brother, husband, wife, daughter, son, step-father, step-mother, step-daughter, step-son, step-brother, step-sister, half-brother, half-sister) and/or those living in the same household of each are not eligible. All federal, state and local laws and regulations apply. Void where prohibited by law.

**3. PRIZE:** For each day Chicago Bears 2019 Training Camp is open to the public, sixty (60) winners (“Winners”) will each receive one (1) pass to enter the Goodwill VIP Autograph Zone. Sponsor reserves the right to substitute a Prize with another of equal value should any unforeseen circumstances occur. All state, federal, and local taxes or other expenses not specified herein, including travel to and from Olivet Nazarene University in Bourbonnais, Illinois, are the sole responsibility of the Winners. No prize substitutions or cash redemption will be made except in Sponsor’s sole discretion.

The Winners must act in compliance with all of the Chicago Bears’ rules and standards for VIP Autograph Access. This means that during the time that the Winners have access to the Goodwill VIP Autograph Zone they must (1) follow all of the instructions provided by the designated Chicago Bears’ representative(s); (2) display appropriate credentials at all times; (3) dress in appropriate attire (preferably Chicago Bears jersey or gear) and refrain from wearing the gear or attire of the game-day opponent or any NFL team except for the Chicago Bears; (4) refrain from unruly, loud and/or disruptive behavior; and (5) avoid showing up in an intoxicated state or otherwise displaying signs of alcohol consumption or use of any controlled dangerous substances. Failure to comply with any of the above may result in disqualification of the Winners at the sole discretion of the Chicago Bears.

**4. SELECTION OF WINNERS:** The Winners will be selected the day prior and the day of the public training camp practice on a first come first serve basis, as supplies last. Odds of winning depends on the total number of eligible entries received and the number of attendees at Chicago Bears training camp each day.

**5. AGREEMENT TO OFFICIAL RULES:** By participating in the Sweepstakes, each Entrant accepts and agrees to comply with and abide by these Official Rules and the decisions of the Sponsor, which shall be final and binding in all respect. In the event of any conflict or inconsistency between these Official Rules and any advertisement, promotional or marketing materials, or other announcements relating to the Sweepstakes, these Official Rules govern.
