

**2018 GOODWILL “GEAR UP FOR BACK TO SCHOOL” IN-STORE TICKET**  
**SWEEPSTAKES**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE.  
A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**1. HOW TO ENTER:** You can enter the 2018 Goodwill “Gear Up for Back to School” Ticket Sweepstakes (“Sweepstakes”) on August 11, 2018 from 12:00 PM – 2:00 PM Central Time (“CT”) by going to the Goodwill Store & Donation Center located at 543 E. North Avenue, Glendale Heights, IL 60139 (“Goodwill Store”).

**Alternate Method of Entry (“AMOE”):** To enter the Sweepstakes without going to the Goodwill Store, you may enter by mail as follows: On a 3" x 5" card, legibly handprint or type your first name, last name, email address, zip code, telephone number (including area code), date of birth (including birth year), and mail your 3" x 5" card in a business size envelope to: 2018 Goodwill “Gear Up for Back to School” Ticket Sweepstakes Entry, Attn: Rachel Chessky, Halas Hall, 1920 Football Drive, Lake Forest, IL 60045.

All AMOE entries must be postmarked by August 8, 2018 and received by August 11, 2018. Limit one (1) entry per envelope. Each envelope is considered one (1) entry into the Sweepstakes. Multiple entries submitted or completed by anyone other than the Entrant are void. No mechanical reproductions will be accepted. AMOE entries must contain all entry fields to be entered, otherwise void.

Any attempt by an Entrant to obtain more than the stated number of entries by using multiple/different addresses, and /or any other methods will void that Entrant’s entries and that Entrant may be disqualified from the Sweepstakes. Entries submitted by anyone other than the Entrant are void. Neither the Chicago Bears, the Sponsor, nor Independent Administrator will verify receipt of entries for Entrants. All entries submitted become the sole property of Sponsor and will not be returned. Sponsor is not responsible for lost, late, misdirected, illegible, damaged or postage-due mailed entries.

**2. ELIGIBILITY:** This Sweepstakes is open to all legal residents of the United States ages 18 years and over as of August 11, 2018, unless prohibited in the state. Employees, officers, directors, agents, and representatives of Goodwill Industries International, Inc. (“Sponsor”), The Chicago Bears Football Club, Inc. (“Chicago Bears”), the National Football League, and each of their respective parents, affiliates, subsidiaries, wholesalers, retailers, distributors, advertising and promotion agencies, and their immediate family members (mother, father, sister, brother, husband, wife, daughter, son, step-father, step-mother, step-daughter, step-son, step-brother, step-sister, half-brother, half-sister) and/or those living in the same household of each are not eligible. All state, federal, and local taxes or other expenses not specified herein, including travel to and from Soldier Field in Chicago, Illinois, are the sole responsibility of the Winner. No Prize substitutions or cash redemption will be made except in Sponsor’s sole discretion.

**4. SELECTION OF WINNER:** The Prize Winner will be selected in a random drawing held at the Goodwill Store at 2:00 PM CT. Odds of winning depends on the total number of eligible entries received.
