

## TERRA'S KITCHEN - September 2017 - Revolution Foods Sweepstakes

Sponsored by Terra's Kitchen ("Sponsors").

**1. Sweepstakes Period:** Terra's Kitchen - September 2017 - Revolution Foods Sweepstakes ("The Promotion") begins on Thursday September 28, 2017 11:00am ET - Saturday September 30, 2017 at 11:59pm ET. The Sponsor of this Promotion is Terra's Kitchen, LLC ("Sponsor"). The Administrator of this Promotion is Terra's Kitchen, LLC ("Administrator"). You understand that you are providing your information to Sponsor (as defined below) and/or Administrator (as defined below) and not to Instagram.

**2. Eligibility:** The Sweepstakes is open to legal residents of the U.S. age 18 or older, who have an active Instagram account and Internet access as of the beginning of the promotion/sweepstakes period.

Employees of Sponsors and their respective parent companies, affiliates, subsidiaries, advertising, promotion, and fulfillment agencies, their immediate family members and persons living in their same household, are not eligible to participate in the promotion/contest.
