Loan Interest Rate & Fees

After the rate is set, it will be fixed for the life of the loan.

Your Interest Rate (upon approval)

The interest rate you pay will be determined after you apply. If approved, we will notify you of the rate you qualify for within the stated range.

Your Interest Rate during the life of the loan

Your rate is fixed. This means that your rate will remain constant throughout the life of the loan. For more information on this rate, see the reference notes. Your rate will never change throughout the life of the loan. The interest rate is determined after you submit your application and is based on term and credit score.

Loan Fees

Late Charge: 6% of the late payment amount. **Returned Check Fee:** \$10.

Loan Cost Examples

The total amount you will pay for this loan will vary depending upon when you start to repay it. This examples provides an estimate based upon the repayment option available to you.

Repayment Option	Amount Provided (amount provided directly to you or your school)	Interest Rate (highest possible starting rate)	Loan Term (how long you have to pay off the loan)	Total Interest Charges
1. 5 Year Refinance Loan - Without Co-signer	\$10,000	6.39%	5 years, first payment is due 30 days <u>after</u> disbursement.	\$1,708.80
2. 10 Year Refinance Loan - Without Co-signer	\$10,000	7.39%	10 years, first payment is due 30 days <u>after</u> disbursement.	\$4,175.41
3. 15 Year Refinance Loan - Without Co-signer	\$10,000	7.89%	15 years, first payment is due 30 days <u>after</u> disbursement.	\$7,087.63

About this example

Assumptions: **ALL EXAMPLES:** Minimum monthly payment is \$50.00. Loan enters repayment immediately following disbursement.

Federal Loan Alternatives

Loan program	Current Interest Rates by Program Type
FEDERAL DIRECT CONSOLIDATION	Weighted average rate of your outstanding Federal Loans, rounded up to nearest 1/8th of 1%

You may qualify for a Federal Direct Consolidation loan.
