## WHAT IS B4B?

B4B provides a link between the payables module within Infor SunSystems and your bank for Electronic Funds Transfers (EFT) or internet banking. B4B is an integrated solution that will streamline and standardise payment processing across your organisation.

B4B increases efficiency, mitigates risk, improves control and increases the visibility over the production of the files required for any bank payments process.

Approval control can even be implemented at a systems and/or business unit level.

- Key data is fully encrypted within the database and there is an option to apply PGP Encryption to the bank file, provided your bank can accept encrypted files
- Audit control tracks all changes to key system data & provides parameter driven audit reports
- System audit includes password control and rules
- Allows for segregation of roles and security adding better control and auditability
- Approval matrix to assist in fraud prevention
- Changes to the bank details are managed within B4B via an approval process.
