

# Privacy Policy

This Privacy Policy applies to all of the products, services and websites offered by Evosus Inc. or its subsidiaries or affiliated companies. Sometimes, we may post product specific privacy notices or Support Center materials to explain our products in more detail. ## Information we collect and how we use it

We may collect the following types of information:

- **Information you provide** – When you inquire or purchase Evosus products or services either by phone, in person or through our website, we ask you for personal information which we use in our database for sales and support purposes.
- **Log information** – When you access the Evosus demo server via windows remote desktop connection, our servers automatically record certain information. These server logs may include information such as your web request, your interaction with a service, Internet Protocol address, browser type, browser language, the date and time of your request and one or more cookies that may uniquely identify your browser or your account.
- **User communications** – When you send email or other communications to Evosus, we may retain those communications in order to process your inquiries, respond to your requests and improve our services. When you send and receive SMS messages to or from one of our services that provides SMS functionality, we may collect and maintain information associated with those messages, such as the phone number, the wireless carrier associated with the phone number, the content of the message, and the date and time of the transaction. We may use your email address to communicate with you about our services.
- **Affiliated Evosus Services on other sites** – We offer some of our services on or through other web sites. Personal information that you provide to those sites may be sent to Evosus in order to deliver the service. We process such information under this Privacy Policy.
- **Third Party Applications** – Evosus may make available third party applications through its services. The information collected by Evosus when you enable a third party application is processed under this Privacy Policy. Information collected by the third party application provider is governed by their privacy policies.

In addition to the above, we may use the information we collect to:

- Provide, maintain, protect, and improve our services and develop new services; and
- Protect the rights or property of Evosus or our users.

If we use this information in a manner different than the purpose for which it was collected, then we will ask for your consent prior to such use.

Evosus processes personal information on our servers in the United States of America and in other countries. In some cases, we process personal information outside your own country.

## Choices

You can use the Evosus website to review and control the information stored in your Evosus online user account. Most browsers are initially set up to accept cookies, but you can reset your browser to refuse all cookies or to indicate when a cookie is being sent.

## Information sharing

Evosus only shares personal information with other companies or individuals outside of Evosus in the following limited circumstances:

- We have your consent. We require opt-in consent for the sharing of any sensitive personal information.
- We provide such information to our subsidiaries, affiliated companies or other trusted businesses or persons for the purpose of processing personal information on our behalf. We require that these parties agree to process such information based on our instructions and in compliance with this Privacy Policy and any other appropriate confidentiality and security measures.
- We have a good faith belief that access, use, preservation or disclosure of such information is reasonably necessary to (a) satisfy any applicable law, regulation, legal process or enforceable governmental request, (b) enforce applicable Terms of Service, including investigation of potential violations thereof, (c) detect, prevent, or otherwise address fraud, security or technical issues, or (d) protect against harm to the rights, property or safety of Evosus, its users or the public as required or permitted by law.

If Evosus becomes involved in a merger, acquisition, or any form of sale of some or all of its assets, we will ensure the confidentiality of any personal information involved in such transactions and provide notice before personal information is transferred and becomes subject to a different privacy policy.

## Information security

We take appropriate security measures to protect against unauthorized access to or unauthorized alteration, disclosure or destruction of data. These include internal reviews of our data collection, storage and processing practices and security measures, including appropriate encryption and physical security measures to guard against unauthorized access to systems where we store personal data. We restrict access to personal information to Evosus employees, contractors and agents who need to know that information in order to process it on our behalf. These individuals are bound by confidentiality obligations and may be subject to discipline, including termination and criminal prosecution, if they fail to meet these obligations.

## Accessing and updating personal information

We ask individual users to identify themselves and the information requested to be accessed, corrected or removed before processing such requests, and we may decline to process requests that are unreasonably repetitive or systematic, require disproportionate technical effort, jeopardize the privacy of others, or would be extremely impractical (for instance, requests concerning information residing on backups), or for which access is not otherwise required. In any case where we provide information access and correction, we perform this service free of charge, except if doing so would require a disproportionate effort. Because of the way we maintain certain services, after you delete your information, residual copies may take a period of time before they are deleted from our active servers and may remain in our backup systems.

## Enforcement

Evosus adheres to the US Safe Harbor Privacy Principles of Notice, Choice, Onward Transfer, Security, Data Integrity, Access and Enforcement. Evosus regularly reviews its compliance with this Privacy Policy. When we receive formal written complaints, it is Evosus' policy to contact the complaining user regarding his or her concerns. We will cooperate with the appropriate regulatory authorities, including local data protection authorities, to resolve any complaints regarding the transfer of personal data that cannot be resolved between Evosus and an individual.
