#### Bay Harbour HOA Long Beach, CA




I have been a 20-year board member of the Bay Harbour

RULE DEVELOPMENT
AND ENFORCEMENT FOR
COMMUNITY ASSOCIATIONS

In this edition of our Rule Development and Enforcement for Communication Associations series, we delve into the topic of Architectural Guidelines. These guidelines can be a real time saver while offering your homeowners a more convenient and efficient avenue towards architectural alterations.

#### Architectural Guidelines

The development of architectural guidelines should begin with a review of the governing documents to determine in what areas the board can allow a change. Usually, a community association's declaration, CC&R's, or master deed provides for architectural changes.

It is in the community's best interest for a board to establish written architectural guidelines for two reasons:

- · Written guidelines indicate to owners what types of changes will be allowed under normal circumstances.
- Written guidelines are a way to avoid claims of arbitrary or selective treatment of owners.

It is in the board's best interest to establish an architectural guidelines committee. A committee can concentrate its effort and attention on this major task alone. It can also act as a buffer between the requesting owner and the board. Here is a list of a few things that would qualify for an established set of architectural guidelines:

- List as many details as possible, such as manufacturer, serial numbers, etc., to avoid misinterpretation of the preapproved list and make it most convenient for your residents to locate the items.
- Paint Colors: Develop a list of approved paint colors an owner can use to paint their home, garage door, front door, etc. Include swatches; if the manufacturer discontinues it, paint from another manufacturer in the same color might still qualify.
- Front/Garage Door Styles: Must the door be solid? Can it have a window? What style/color storm/screen doors are pre-approved? If the style installed by the the builder is discontinued, what replacement styles are pre-approved? List manufacturer and model # of pre-approved styles.
- Windows: What style windows are pre-approved for window replacements? Must they be wood or vinyl? Must they open one specific color?
- Fencing: What style, color and/or height fencing is pre-approved?
- Roofing: What material, style, color and lifespan roofing material is pre-approved?

The more architectural guidelines you establish with pre-approved items, the more convenient the architectural alterations process will be for your homeowners. You might even elect to state that the owner can bypass the ACC approval process altogether if they use one of these pre-approved items, making it not only more convenient, but also more efficient for all parties involved.

#### LEBRECHAUN COSTUME PHOTO BOOTH

Encourage members to dress in their best leprechaun costume and provide a photo booth to capture the fun. Add props for the booth using free online printable templates. Photo booths help create social media engagement as members share pictures of them enjoying the HOA event with family and friends.

#### POT-OF-GOLD COIN TOSS

Provide chocolate-covered coins for children to toss into decorated pots. Plan distances according to age groups and supply prizes to those who get the most coins in the designated pot. Not only is the game fun for children, but it also helps them practice hand-eye coordination.

#### LUCKY LEPRECHAUN SCAVENGER HUNT

Have members test their luck at finding all items listed on a preprinted card. Hide objects in advance of the event and have cards available at the door. Encourage members to ask others for clues — not answers — regarding the location of objects. A scavenger hunt can increase networking among members and increase networking among members and increase event participation as players seek to complete the list.

Celtic music and dancing can liven up any St. Patrick's Day event. You don't have to know how to dance an Irish jig to enjoy the sounds of this popular music. Visit a local craft store for a supply of green pipe cleaners. Have printed images of shamrocks available as a guide and let participants make their own shamrock to pin to their clothing or simply take home.

A St. Patrick's Day party isn't complete without magically delicious treats. Here are a few ideas, healthy and sweet, for families to create together during the event.



#### **LUCKY CHARMS PARFAIT**

#### **INGREDIENTS**

- 1 cup of Lucky Charms cereal for each serving
- 1 1/2 cups Greek yogurt for each serving
- 4 drops green food dye (optional)
- 1 teaspoon mint or vanilla extract (optional



#### **INSTRUCTIONS**

- Pour the Lucky Charms cereal into a large bowl and remove the marshmallows, set them aside.
- Fill the serving dishes with 1 cup of Lucky Charms cereal for each serving. You can also layer the Lucky Charms cereal with the yogurt in alternating layers.
- Wipe out the bowl you used to separate the Lucky Charms and then add your greek yogurt.
- Give it a good stir to remove any lumps before adding the optional food dyes and extracts. Mix in and adjust to taste or color preferences.
- Carefully spoon the yogurt over the top of the cereal and then sprinkle on the marshmallows.

#### **LUCKY CHARMS POPCORN BALLS**

Prep Time: 15 minutes

**Cook Time: 5 minutes**

#### **INGREDIENTS**

- 1/4 cup butter
- 1/3 cup brown sugar
- 2 cups mini marshmallows
- 3 quarts plain popped

#### popcorn

- 1 cup marshmallow cereal (only the marshmallows!)
- Green sprinkles

#### INSTRUCTIONS

- In a saucepan over medium heat, combine butter, brown sugar, and marshmallows. Stir constantly until mixture is completely melted and smooth.
- Place the popcorn in a large bowl, and then pour the hot mixture over the top of the popcorn. Add in the marshmallow cereal and liberally dust with green sprinkles. Use a

large spatula to mix ingredients and combine everything well.

 Grease two clean, plastic, kitchen gloves with cooking spray and begin to shape the coated popcorn into balls (about tennis ball sized). Store in an airtight container when finished.

Here are some additional ideas for treats.

Shamrock Cookie Decorating – Provide pre-baked, shamrock-shaped cookies with lots of green icing and sprinkles.

Ice Cream Toppings — Use vanilla or green mint ice cream and offer a choice of toppings as well as Lucky Charms.

Rainbow Fruit Skewer - Cut up small pieces of fruit and provide skewers for this healthy treat. For extra fun, include pattern cards as a learning tool for children. Use special care with the skewers and encourage safety.
