Claim Example



Four teenage boys returning home from a high school sporting event, were driving too fast and lost control of vehicle, sending the vehicle off road and into a ditch. One passenger was severely injured and required life flight, extended hospital stay, several surgeries and a lifetime care. Total claim expenses exceeded \$1,900,000 with continued claim costs still being paid to date. Over \$900,000 worth of expenses would NOT have been covered under health insurance; leaving a significant gap in coverage.
