## WHAT DOES Wyndham Capital Mortgage, Inc. DO WITH YOUR PERSONAL INFORMATION?

### Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- **Social Security number** and **Payment history**
- **Income** and **Credit history**
- **Credit scores** and **Assets**

### How?

All financial companies need to share **Customers** personal information to run their everyday business. In the section below, we list the reasons financial companies can share their **Customers** personal information; the reasons **Wyndham Capital Mortgage, Inc.** chooses to share; and whether you can limit this sharing.

### What we do

How does Wyndham Capital Mortgage, Inc. protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does Wyndham Capital Mortgage, Inc. collect my personal information?

We collect your personal information, for example, when you

- **Apply for a loan** or
- **Give us your income information** or
- **Provide employment information** or
- **Give us your contact information** or
- **Provide your mortgage information**

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes — information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

What happens when I limit sharing for an account I hold jointly with someone else?

**Your choices will apply to everyone on your account**

### Definitions

**Affiliates**

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- **Wyndham Capital Mortgage, Inc. has no affiliates.**

**Nonaffiliates**

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- **Home search application**

**Joint marketing**

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- **Wyndham Capital Mortgage, Inc. does not jointly market.**

### Other important information

**Vermont is an "opt in" state and the consumer must grant Wyndham Capital Mortgage the right to share his/her information before your information can be shared.**
