• If the subject of the request disagrees with the report received, they may challenge the report by requesting a hardcopy Form SP4-164, Request for Criminal Record Check, from the Records and Identification Division by mail. This Form SP4-164 must have the Individual Access and Review block check marked, be completed and returned to the Records and Identification Division. A complete copy of the individual's criminal history along with a challenge form will be mailed to the individual. The form must be completed and returned to the Central Repository within 30 days of receipt. If the subject of the request claims the criminal history received is not his/hers, a fingerprint comparison must be made.

If you believe your Federal Identity History Summary contains inaccurate or incomplete information, you have two options for requesting a change or correction

- Option 1: Contact the agency or agencies that submitted the information to the FBI for Missing or Incorrect State (Non-Federal) Information
- Option 2: Send a written challenge request to the FBI's CJIS Division Missing for Incorrect Federal
 Information

Your written request should clearly identify the information that you feel is inaccurate or incomplete and should include copies of any available proof or supporting documentation to substantiate your claim. The FBI will contact appropriate agencies in an attempt to verify or correct challenged entries for you. Upon receipt of an official communication from the agency with jurisdiction over the data, the FBI will make appropriate changes and notify you of the outcome. You may submit an Identity History Summary challenge to the FBI's CJIS Division by writing to the following address:
