

WARRANTY - MODEL D-999FR GRAIN MOISTURE TESTER

The manufacturer guarantees each new moisture tester is free from defects in material, workmanship, assembly and components setup. The product warranty is five (5) years (conditional) from date of retail purchase**. This warranty does not cover damage resulting from misuse, neglect, accident or improper installation or maintenance.

THIS WARRANTY IS IN LIEU OF ALL OTHER WARRANTIES OF MERCHANTABILITY, FITNESS FOR PURPOSE AND OF ANY OTHER TYPE, WHETHER EXPRESSED OR IMPLIED. The manufacturer neither assumes nor authorizes any representative or other person to assume for it any liability in connection with the sale of this equipment.

In no event shall the manufacturer be liable for any special, indirect, incidental, or consequential damages and its liability under the warranty shall be limited solely to the repair or replacement of parts. In no case shall the manufacturer be responsible for loss of productivity, data, direct or indirect damages, claims by third parties, strikes or any other losses or expenses, including lost profits.

This warranty does not apply to any product which has been repaired or altered outside an authorized manufacturer repair facility.

****The 5 year warranty is automatically void if:**

- The equipment has not been returned to Delmhorst Instrument for the annual maintenance that includes inspection and repair or replacement of parts as needed, and updated calibrations. In such cases a one year warranty (parts and labor) applies.
- The serial number and/or sealing label has been tampered with or removed. In such cases all warranties are void.

- Equipment damaged by insects or rodents.
