# MESSAGE FROM THE CHAIR

In 1989, following a measure passed by the Texas Legislature, Amarillo became the second community in Texas to invest a voter-approved ½ cent sales tax in a local economic development initiative. In 1990, the Amarillo Economic Development Corporation (EDC) was formed, and our community had its own organization dedicated to the recruitment, expansion, retention and entrepreneurial development of business and industry in our area. This year we celebrate a quarter-century of building a stronger, more diversified economy. We are humbled to have played a role in enhancing the economic growth in Amarillo and the surrounding area, with the goal of achieving success in meaningful ways, a few of which are outlined below and in the following pages.

Over the last 25 years, the Amarillo EDC has engaged in over 100 projects with more than 100 companies, creating a "Portfolio of Success". According to a recently commissioned independent analysis (*Amarillo Advantages and the Contribution of the Amarillo EDC: Current Conditions and a Look Back Over 25 Years of Investing in the Local and Regional Economies*) by the research firm The Perryman Group, **the annual economic benefits stemming from companies assisted by the Amarillo EDC include \$5.5 billion in gross product each year and 54,141 permanent jobs in the Amarillo Metropolitan Statistical Area (MSA).** This overall impact represents about 44.4% of the economy and 62.8% of the incremental growth since the inception of the organization. This economic activity led to gains for local taxing entities of an estimated \$198.3 million each year, as well as \$297 million in annual tax receipts to the State. In addition, wages in the area have risen significantly over time with growth out-pacing most similarly-sized cities.

> This growth pattern is expected to continue. The Perryman Group's forecast for the 2013-2018 time horizon calls for expansion in real gross product of 4.14% per year, resulting in an increase of almost \$2.13 billion by 2018. Additionally, nearly 13,000 jobs are likely to be added over the period. The past and anticipated future activities of the Amarillo EDC will serve as a major source of stimulus. # STRATEGIC DIRECTION

The mission of the Amarillo EDC is to promote business expansion in the greater Amarillo area that builds a stronger, more diversified economy and increases the economic vitality and wealth of the community. To accomplish our mission, the organization is focused on recruiting business and industry that attract highly-skilled positions at high wages, retaining and expanding existing business and industry in Amarillo and the surrounding area, and creating a business environment conducive for entrepreneurship. The Amarillo EDC annual Plan of Work calls for an aggressive business recruitment, retention and expansion program executed by developing strong relationships with the existing Amarillo area business community, promoting the Amarillo EDC brand and working with partner agencies and consultants that support the mission.

In celebration of its 25th anniversary milestone, the Amarillo EDC commissioned The Perryman Group to conduct an analysis of the organization's impact on the greater Amarillo community since its

formation in 1990. The report, entitled Amarillo Advantages and the Contribution of the Amarillo Economic Development Corporation: Current Conditions and a Look Back Over 25 Years of Investing in the Local and Regional Economies, provides both a historical and current perspective on the Amarillo EDC's contributions to the community.

# THE PERRYMAN ANALYSIS

The report states:

"In the late 1980's, the Amarillo area was struggling with lackluster business conditions and constrained opportunities for area residents. The unemployment rate was higher than the national average and consumer activity was in a state of decline. There was a pressing need to jumpstart the Amarillo economy and provide diversity to the stakeholders within the community."

With the passage of enabling legislation at the State level to allow for sales tax funding for economic development and a positive vote in a local referendum, the stage was set for a new era in economic growth.

"The creation and implementation of the Amarillo EDC was monumental and historic in defining the future prospects for the entire Panhandle region. With visionary leadership, the passage of the measure reflected the desire of the community to secure sustainable business growth and expansion. The additional activity resulting from focused efforts of the Amarillo EDC has provided tens of thousands of jobs for the people of Amarillo and the surrounding areas, as well as fostered increased investment and opportunities for local businesses across a spectrum of industries. Moreover, the increase in business activity has generated millions of dollars in tax revenues to be utilized by cities, counties and school districts in the area, which funded key local priorities."


# THE PERRYMAN ANALYSIS

The study went on to state:

"The Amarillo EDC has been working for the past 25 years to market the area to prospective firms, provide assistance for relocations and expansions, and improve workforce training to meet business needs. Companies that have received location or expansion assistance from the Amarillo EDC generate annual economic activity in the area including \$5.5 billion in gross product each year and 54,141 permanent jobs in the Amarillo MSA, with additional business activity spilling over into the surrounding region."

With study results that yield positive statements like these from organizations as renowned as The Perryman Group, we are confident the Amarillo EDC continues to move in the right direction. By a variety of measures, the impact on Amarillo and a large portion of the Texas Panhandle has been dramatic. # ACCOMPLISHMENTS

## **BUSINESS DEVELOPMENT**

The Amarillo EDC continued to promote the Amarillo area as a competitive location for new primary businesses and industries, with a specific focus on companies paying an average wage that meets or exceeds the average wage for the Amarillo labor market. This was accomplished by building relationships with representatives of companies in our target industry mix, actively working with existing business and industry executives and by engaging in activities with professional facility-planning and site-location consultants.

## **Accomplishments for the Year**

**Began construction of Coca-Cola Refreshments' (CCR) new \$9 million distribution center facility on a prime site in the** CenterPort Business Park. The project is expected to be completed in March 2015. It will enable CCR to retain its employment base in Amarillo and potentially add new jobs, while adding technological improvements to the facility. CCR's former property in downtown Amarillo will be the site for a new multi-purpose event venue (MPEV). The MPEV is a key component of the City's downtown revitalization initiative, and will serve as a catalyst for development of the convention hotel and numerous growth opportunities. The Amarillo EDC's support of this project is critical to the City's downtown revitalization plan.

## Purchased the Commerce Building in downtown Amarillo

for redevelopment as West Texas A&M University's (WTAMU) new Amarillo Center. WTAMU is working with the community to raise the funds to refurbish the 100,000 square foot building as Phase One of a multi-facility downtown campus. The project is expected to be ready for classes in the Fall of 2016 and will be the catalyst for a multi-million dollar expansion of WTAMU in Amarillo.

**Completed a new ten-year lease agreement with MWI/Micro Beef Technologies** to move the company and consolidate operations into the former Zarges Building in the CenterPort Business Park. The expanded building will enable the company to bring several operations into one facility and retain 120 jobs in Amarillo. MWI/Micro Beef Technologies will lease the building from the Amarillo EDC at market rates after the \$1.6 million expansion is completed.

Amarillo Gear's expansion into the PRANA Development Group's new building in the CenterPort Business Park is under construction. The company will lease the remaining 28,000 square feet of the 50,000 square foot speculative building that PRANA constructed with the Amarillo EDC's support. It will house a new operation with 20-30 new jobs in Amarillo.

# ACCOMPLISHMENTS

## **BUSINESS RETENTION AND EXPANSION PROGRAM**

The Amarillo EDC conducted a proactive Business Retention and Expansion (BRE) initiative that supports the continued growth and expansion of existing business and industry in the Amarillo area.

## **Accomplishments for the Year**

**Conducted a business outreach campaign in collaboration with the Mayor and the Amarillo Chamber** of Commerce with a variety of primary, service and small businesses throughout the program year.

Staff met one-on-one with over 100 existing Amarillo businesses as well as current and past EnterPrize Challenge participants to keep a finger on the pulse of the existing business community in the greater Amarillo area.

Participated in the Amarillo Chamber of Commerce's annual "Business Connection" tradeshow. The Amarillo EDC exhibited at the event and worked the floor to connect with dozens of local companies exhibiting at the event.





## The Texas Panhandle Regional Development Corporation (TPRDC) approved seven SBA 504

loans totaling \$6,085,000, which leveraged \$14.9 million in bank financing and more than \$5.3 million in owner equity as well as the creation of 57 new jobs. TPRDC also funded four loans in 2014 totaling \$4.5 million. TPRDC operates the City of Amarillo Micro Loan program and approved one loan in FY14 totaling \$35,000. Since inception, this program has funded six loans totaling \$143,897 with a goal of making access to financing more available to low and moderate income individuals.

# ACCOMPLISHMENTS

## **PROMOTING ENTREPRENEURSHIP**

The Amarillo EDC continued to work with partners in the region, particularly the West Texas A&M University (WTAMU) Enterprise Center, to expand the EnterPrize Challenge business plan competition and strengthen the business environment for small business owners to achieve success.

## **Accomplishments for the Year**

The 2014 EnterPrize Challenge, administered by the WTAMU Enterprise Center, awarded five companies grants totaling \$500,000 in the 19th annual business plan competition. These new and emerging companies will create new jobs and make significant investments in the regional economy. To date, 69 companies have received Challenge grants totaling \$4.6 million over the past 19 years. They have created 636 new jobs and brought more than \$119 million into the local economy. Additionally, the grants have leveraged more than \$11.6 million in capital investment from EnterPrize Challenge winners.





## The WTAMU Enterprise Center launched the Entrepreneur "Eco-System" initiative in 2014 with

the assistance of a \$250,000/year grant for up to five years from the Amarillo EDC. As part of the initiative, the Enterprise Center and Amarillo EDC will partner to bring an enhanced level of support to the small business community via a business facilitation services contract with Leading EDG, a local technical assistance firm. The program will leverage funding from the US Economic Development Administration and the Amarillo Area Foundation.

## WORKFORCE DEVELOPMENT

The Amarillo EDC continues to position itself as a primary supporter of workforce development initiatives throughout the region. Amarillo EDC also nurtures established relationships and develops new relationships with organizations that support its mission.

**Provided continuation funding in the amount of \$100,000 to the Amarillo Area Foundation for the** "No Limits, No Excuses" workforce development program, initiated by a grant from the Bill & Melinda Gates Foundation, with a goal of dramatically increasing the number of low-income young adults who successfully complete post-secondary credentials to obtain living wage employment.

## Highlights of a

## Year Legacy of Success

## 1991

The Amarillo EDC offered assistance for the addition of machinery to the Amarillo Gear Company machine center resulting in the addition of 30 new jobs. Additionally, the AEDC supported the expansion of the Anderson Merchandisers facility resulting in the creation of more than 100 jobs.

## 1993

ARDO

The Amarillo EDC approved its first project under the Small Business Interest Rebate program. Amarillo Mop & Broom Company received assistance in the form of an interest rebate on a commercial loan to fund operations.

## 1995

The Amarillo EDC attracted Sitel and Arden/Paradise to locate facilities in Amarillo.

The Amarillo EDC assisted Plains Diary with their initiative to expand operations and facilities. The Amarillo EDC attracted Atmos Energy and Nationwide Insurance to locate facilities in Amarillo.

## 1989/1990

Amarillo was the second city in Texas to pass the 1/2 cent sales tax for economic development and create an economic development corporation. Michael Bourn was hired as the organization's first president.

The Amarillo EDC joined the newly formed regional economic development coalition, The High Ground of Texas. This signified the beginning of a legacy of regionalism which still continues today.

## 1994

The community's first-ever business plan competition, The Amarillo EnterPrize Challenge, was created. The Amarillo EDC began funding cash grants to winners, who were required to be primary businesses exhibiting high growth and economic impact potential.

The Amarillo EDC was an early-adopter in launching its first-ever website www.amarillo-tx.com

## 1996

The Amarillo EDC helped fund the development and construction of the Texas Tech Health Sciences Center School of Pharmacy.

### 1999

Amarillo EDC stepped up as a Foundation Member during the reorganization and expansion of The High Ground of Texas organization.

Amarillo EDC worked with Progress Rail Services and McCoy, Meyers and Associates as both companies expanded facilities to meet growing demand. The projects resulted in the creation of over 100 jobs in the area.

### 2001

Amarillo EDC filed for and received Foreign Trade Zone status for Zone 252 in the Amarillo area. This designation benefits local companies conducting business internationally and allows import/export activity more expediently and at reduced expense.



## 1998

The Amarillo EDC attracted Bell HelicopterTextron to locate a facility in Amarillo. This was the first of seven expansions for the firm and one of Amarillo EDC's most significant projects to date.

The Amarillo EDC attracted Rocla Concrete Tie Co. to locate facilities in Amarillo.

## 2000

With financial assistance from the Amarillo EDC, the Texas Tech Health Sciences Center expanded its Amarillo campus by adding a School of Medicine and School of Allied Health alongside the already operational School of Pharmacy.

## 2002

The Amarillo EDC attracted Western National Life, formerly AIG Insurance, to locate a facility in Amarillo.

The Amarillo EDC helped fund the development of a Masters of Engineering Program at Texas Tech University.

## 1997

The Amarillo EDC attracted SciCronTechnologies to locate a facility in Amarillo.

2003

With the Amarillo EDC's assistance, Ben E. Keith completed construction on a 307,000 square foot facility in CenterPort Business Park.

The Amarillo EDC helped fund the development of an Engineering Program at West Texas A&M University.

### 2005

The Amarillo EDC attracted Composite Shapes to locate a facility in Amarillo.

The Amarillo EDC, in tandem with other community EDCs, attracted Hilmar Cheese Co. to locate a facility in Dalhart, Texas. This was the first project funded outside the City and demonstrated "what was good for the region was good for Amarillo."

## 2007

The Amarillo EDC assisted in funding the development of the West Texas A&M University downtown Amarillo campus, located in the Chase Building at 6th & Tyler.

Blue Cross Blue Shield of Texas opened its customer care center in Amarillo. The center, a multi-million dollar investment by the company, employed more than 200 area residents once fully operational.

## 2009

The Amarillo EDC, in support of The High Ground of Texas Education Foundation, generously became a founding donor of the David Evans Spirit of Giving Scholarship Fund. The Fund provides annual scholarships for rural High Ground members to participate in the Basic Economic Development Course.

## 2004

Richard (Buzz) David was hired as President and CEO of the Amarillo EDC. The organization generated a "Portfolio of Success" to highlight successful projects to date and to report on the community's return on investment.

Amarillo College received assistance from the Amarillo EDC in the establishment of two workforce programs. The Robotics Training Program and Non-Destructive Testing Program were designed to meet the needs of companies in the area.

## 2006

Richard (Buzz) David received the coveted The High Ground of Texas Top Gun Award, a special honor bestowed upon High Ground members who have displayed an exceptional attitude towards regionalism, have participated in numerous High Ground events and have promoted the region in a manner above and beyond expectations.

## 2008

The Amarillo EDC was inducted into The High Ground of Texas Hall of Fame as an inaugural Honoree.

The Amarillo EDC attracted Pacific Cheese Co. It was the second building project in the CenterPort Business Park.

The Amarillo EDC helped fund the development of a wind technology program at Amarillo College.

The Amarillo EDC contracted a speculative building in the CenterPort Business Park.



## 2012

The Amarillo EDC assisted with the development of a new 250,000 square foot facility to house the assembly operations for the 525 Relentless division at Bell Helicopter. This \$30 million project will bring 115 new jobs to Amarillo with an estimated payroll and benefits impact of \$15 million per year.

The Amarillo EDC approved \$500,000 in matching funds to support the expansion of Sim Central, a multi-institutional training center serving multiple medical disciplines. The collaboration includes Texas Tech University Health Sciences Center, Amarillo College and West Texas A&M.

## 2014

In 2014, the Amarillo EDC approved additional funds to purchase the Commerce Building, which began the first phase in creating a permanent WTAMU campus in the heart of downtown Amarillo.

# ENTERPRIZE CHALLENGE

The Amarillo EnterPrize Challenge is a business plan competition administered by the West Texas A&M Enterprise Center and funded by the Amarillo EDC. A business is eligible to receive a portion of a \$500,000 grant if its goods and services are primarily sold outside the region, bringing new revenue to the Amarillo economy. The amount awarded to one business can be as much as \$100,000. This competition encourages participation from start-up companies and established businesses.

To date, through the Amarillo EnterPrize Challenge program, 69 companies have received cash grants of as much as \$100,000 each, totaling more than \$4.6 million in grants over the past 19 years. In addition, these companies have received more than \$12.6 million in additional equity capital since receiving their grants. Reporting firms have 636 employees and generated \$119 million of revenue for the Amarillo economy.




