

# **Power User Reporting**

## **Course Description**

This 1-day hands on course highlights the main reporting concepts in OneStream XF. This introductory class covers Cube View functionality and design for grid analysis and reporting, the building blocks of Dashboard Maintenance Units and Spreadsheet/Excel Add-In features such as Quick Views and Retrieve Functions.

## Who Should Attend

OneStream XF Users who help build reports in OneStream but are not administering the entire application.

This course was designed for users who want to develop their reporting skills, but do not have a need for all the material in the four-day Application Build for Administrators. The Power User Reporting class covers the same reporting content as Application Build. Completion of this course allows users to attend Level 2 Reporting.

## Registration
