## EXACT Category 1 Definition

There are four (4) distinct categories of EXACT Assessments, all of which are subject to strict adherence to the EXACT Program and monitoring thereof by Wyvern.

EXACT Assessment Categories have been introduced to meet market and customer needs, particularly with regard to the vast range of UAS/RPAS Operations.

An EXACT Category of an EXACT Assessment is determined by:

- The UAV/RPA maximum take-off mass (MTOM)
- Type of operation: operated VLOS or BVLOS and
- Height above ground level, AGL

The UAV/RPAS with the highest MTOM governs the EXACT Assessment Category.

There are four (4) EXACT Assessment Categories:

Category 1	<25 kg (55 lbs.)	VLOS
Category 2	25 kg up to <150 kg (330 lbs)	VLOS
Category 3	<150 kg (330 lbs)	BVLOS
Category 4	150 kg (330 lbs) and above	BVLOS



A Category 1 Assessment is a one-day desktop (remote) EXACT Assessment, performed by an EXACT Assessor.

The scope of the Category 1 Assessment includes a review of an operation's Organization, Management and Structure, Safety and Quality Management Systems, manuals, certificate of insurance as well as reviewing technical factors. Technical factors include the UAV, Remote Pilot Station, Payload, Data Link/Command and Control and Support Equipment.
