## **STEGO EMBARKS ON HPD PILOT PROGRAM**

Industry-Leading Vapor Barrier Company Strives to Provide Better Green Choices to Designers and Builders

**SAN CLEMENTE, Calif.** – Stego Industries, LLC, the most-specified concrete vapor barrier company in the United States, signed on Thursday to the Health Product Declaration Open Standard (HPD), a voluntary format for disclosing product content and related health concerns that are typically not reported even when a product or a building is certified "green."

The company will prepare an HPD for its flagship product, STEGO<sup>®</sup> WRAP vapor barrier, which it will submit to the HPD Working Group. The Working Group will evaluate and synthesize the feedback and revise the draft HPD into a final version that will be officially ratified and made available to the public later this year. 30 of some of the most important names in the construction industry, representing a wide variety of products, will help refine the HPD Open Standard to provide information to customers that is reliable and actionable, through a process that is reasonable and fair to all manufacturers.

"Stego's industry-leading line of vapor barrier products is not just the choice of green builders because of its ability to reduce energy costs by protecting the building envelope from the diffusion of water vapor, contaminants, and soil gases," Stego Chief Executive Officer Paul J. Blasdel said. The HPD Open Standard Working Group is a voluntary association of experts from the community of building designers, specifiers, owners and users.
