

Step Therapy Updates

Effective July 1, 2017

The Blue KC Medical and Pharmacy Management Committee consists of practicing physicians and pharmacists in the Kansas City area who review and maintain our prescription drug list. The committee holds quarterly meetings to evaluate new drug therapies and review drug utilization issues, evaluating on the basis of drug effectiveness, safety and costs.

The committee recently approved changes to the prescription drug list effective July 1, 2017. The prescription drugs listed below will now require members to first try a medication that is proven to be safe and effective for treating conditions or symptoms, but is lower cost. If this medication doesn't work properly (symptoms persist, unwanted side effects, allergy, etc.), their doctor can request prior authorization to allow them to take the non-preferred drug. This process is known as Step Therapy.

Members must try a preferred therapeutic alternative before other drugs will be covered. These requirements will apply when there is no claims history within the recent 12 months of the preferred therapeutic drug(s).

If a doctor believes the non-preferred medicine is the only medically necessary therapy, he or she will need to submit a prior authorization request on the member's behalf to Blue KC to request a clinical exception. These requests will be evaluated by a clinician. If an exception is approved, the prescription will be covered under the member's Tier 3 benefits.

The new medications that will be subject to step therapy beginning July 1 are included in the following table:
