If a notifiable incident occurs, you must notify us immediately on *13 10 50* as an urgent investigation may be needed and notify your insurer within 48 hours. The incident site must be preserved until an Inspector attends (or the inspector or regulator directs otherwise).

### Work Safe ACT

Immediately after becoming aware that a notifiable incident under the Work Health and Safety Act 2011 or dangerous occurrence under the Dangerous Substances Act 2004 has occurred, a person in control of a business or undertaking or person in control of premises respectively must ensure that Access Canberra is notified of the notifiable incident or dangerous occurrence by the fastest possible means, either by: Phone:

Within 48 hours of the initial notification, Access Canberra must be notified in writing of the notifiable incident or dangerous occurrence by completing the relevant form:

# Safe Work SA

South Australia's work health and safety laws require a person conducting a business or undertaking (PCBUs) to notify SafeWork SA of any serious injuries or illnesses, dangerous incidents or deaths that occur at work immediately after becoming aware that it has occurred by: *Phone: 1800 777 209* 

You may also notify SafeWork SA in writing by email or fax using the Notifiable Incident Report Form but please do not use this form to report immediately life threatening issues or a death. <u>More information and associated forms here:</u>

## Work Safe NT

A Person Conducting a Business or Undertaking (PCBU) is required to contact NT WorkSafe immediately after becoming aware of a notifiable incident at their workplace. Notification must be done by the fastest possible means by either:

A PCBU may also be required to complete and submit an 'Incident notification form' to NT WorkSafe. A PCBU who is required to submit an 'Incident notification form' has 48 hours from the time they notified the incident by phone.
