Our Commitment to Data Protection Regulations

Allegis Partners ("AP") has made compliance with Data Protection Regulations ("DPR") a top priority. AP's parent company, Allegis Group, has a dedicated global privacy program committed to respecting the privacy rights of individuals who entrust personal data to us.

Data Protection Regulations, such as the General Data Protection Regulation (GDPR), California Consumer Privacy Act (CCPA), Personal Information Protection and Electronic Documents Act (PIPEDA), Australia's Privacy Act, ePrivacy Regulations (ePR), and the Philippines' Data Privacy Act, regulate the collection, handling, use and storage of personal data. Data Protection Regulations increase the obligations on organizations who collect or process personal data.

About the Allegis Group Global Privacy Office

The Global Privacy Office's mission is to support Allegis Group's (including all operating companies like Allegis Partners) commitment to the appropriate collection, use and sharing of personal data. The Global Privacy Office has key leaders in the United States, EMEA and APAC that coordinate with our Global Privacy Officer, who is designated as a Fellow of Information Privacy (FIP). Our Global Privacy Officer is also CIPP-US, CIPP-C, CIPP-E and CIPM certified through IAPP. Additionally, AP, along with each operating company, has a dedicated Privacy Analyst that assists with the implementation of our DPR readiness strategy in partnership with the Global Privacy Office. Each member of the team brings their subject-matter expertise, including numerous IAPP certifications, and deep knowledge of their respective businesses. Additionally, Allegis Group has a centralized Global Data Protection Oversight Committee comprised of its most senior leaders within Privacy, Legal, Human Resources, Finance, Compliance, Marketing, Strategy, Information Services, Information Security, and Corporate Development to oversee the company's global privacy initiatives.

Allegis Group has also appointed an external Data Protection Officer ("DPO") to act as our official DPO under GDPR and to provide additional expertise and support to the mission of the Global Privacy Office.

Understanding the role that you play as either a Controller/Business or Processor/Service Provider is an important component of DPR. While each regulation has specific nuances, the following outlines our stance under each of GDPR and CCPA with regards to our service offerings.

Controller/Business: Determines the means and purposes of the processing of Personal Data (the "how" and the "why")

Processor/Service Provider: Processes Personal Data on behalf of the Controller/Business

Transferring Personal Data

Allegis Partners is committed to responsibly and lawfully transferring personal data of our clients while performing our services that involve data subjects from many different countries and regions. In order to do this, AP has the following mechanisms in place, for example, to handle transfers of personal data that involve data subjects from the EEA and/or Switzerland:



We are EU-US and Swiss-US Privacy Shield certified and have been since the inception of the Privacy Shield Framework. Please see our certification <u>here</u>.



Model Clauses

We make use of the Model Contract Clauses as appropriate with our business partners.



Intra-Group Data Transfer Agreement

We have an Intra-Group Data Transfer Agreement using the EU Controller to Controller Model Clauses that also includes the appropriate provisions required under GDPR to cover personal data transfers between and among our businesses globally. While we generally rely on our Privacy Shield certification for transfers from the EEA and Switzerland to the US, the intragroup data transfer agreement provides a second method of transferring that same data while also providing us with a mechanism to allow us to transfer data from the EEA and Switzerland to our companies outside of the US (for instance to our entities located in APAC).



We ensure an adequate transfer mechanism is in place when our suppliers are processing personal data outside of the EEA.
