Definition of Care or Service:

The Hyperbaric Technologists Supervisor works with the physician in the supervision of the technical staff for the treatment of patients receiving Hyperbaric Oxygen Therapy. The scope of service may include:

- Oversight and maintenance of hyperbaric chamber and other clinic facilities
- Report directly to Med Dive partners and the medical director
- Perform clinic duties
- Insure that all protected patient and facility information is kept private and secure.
- Implementation of policies and procedures of Med Dive LLC and North Hills Hospital in the hyperbaric department.
- Maintain patient healthcare records.
- Communicates with North Hills Hospital administration concerning hyperbaric oxygen therapy matters.
- Demonstrates Clinical and Service excellence behaviors to include code of HCA conduct core fundamentals in daily interactions with patients, families, co-workers and physicians.
