### Security Guard - Armed:

The Security Guard - Armed must have the equivalent qualifications and competencies as employed individuals performing the same or similar services at the facility.

### **Definition of Care or Service:**

The Security Guard - Armed provides excellent customer service for the patients, visitors, and employees of the healthcare facility. They also provide a safe environment in the protection and services to healthcare patients, visitors, employees, medical staff, tenants and all other persons on the hospital campus. Security Guards utilize a systematic integration of personnel, technology and proactive and reactive programs. Armed Guards consists of carrying and the use of a self-defense weapon such as a taser or handgun. Scope of Service may include:

- Provides assistance to customers, employees and visitors in a courteous and professional manner.
- Makes routine and random patrols of the hospital buildings and grounds
- Maintains daily log, documenting unusual activities during shift including unlocking secured areas after business hours.
- Performs security patrols of designated areas on foot or in vehicle
- Watches for irregular or unusual conditions that may create security concerns or safety hazards.
- Investigates and prepares reports on accidents, incidents, and suspicious activities. Maintains written logs as required by the post.

### Setting(s):

 HCA entities including healthcare facilities, free standing ED, Imaging Centers, HCAPS, Data Centers, Warehouses, etc.

**Supervision:** Chief Operating Officer, Vice President of Operations or designee

Evaluator: Hospital Director/ Manager (e.g. Facilities Mgmt, Safety & Security, Human Resources)

## Tier Level: 2

#### Qualifications:

- Must be a U.S. citizen or a foreign citizen authorized to legally work in the United States
  21 years of age
- High school diploma or GED
- Pass any State-requirements
- HIPAA training
- Criminal background check Not convicted of a crime related to violence/ moral turpitude
- Not listed on the Violent sexual offender/ predatory registry Required immunizations per DHP divisional requirements

NOTE: Where education may not be defined in qualifications area of the Scope, HCA requires the highest level of education completed (not training or courses) confirmed on your background check.

### **State Requirements:**

- Armed Guards are commissioned Level III (Armed guards can work unarmed with a Level III)

## Other Requirements:

- This position requires an individual to be able to stay on his or her feet for eight consecutive hours, walk long distances up to five miles per day, climb four flights of stairs and have the physical strength to confront whatever situation is unfolding, and the ability to lift up to 50 pounds.
- Only HCA approved firearms, and OC pepper gel may be carried as duty weapons on HCA property by guards certified to carry the specific weapons.
- Armed security guards are allowed to carry firearms that they have successfully completed firearms qualification training.
- Authorized duty holsters must have a minimum Level II retention capability.
- Only hollow point ammunition is approved. Absolutely no reloads, remanufactured, alterations or modifications of any kind to ammunition is permitted.
