- Data collection according to Hospital policy as it relates to; distinguishing significant from insignificant findings and acts upon data (i.e. critical values, questionable results, dilutions, calculations and repeat tests).
- Verifies test ordering practices and eliminates unnecessary duplication. Performs **instrument function** verification, documents equipment function, performs QC and protocols and maintenance as required.
- Prepares cell culture media, and purification buffers
- Performs procedures for frozen sections, embedding with correct orientation of tissue, cutting for specific protocols and correct staining to ensure the integrity of the specimen.

 - o Practices consistent hand hygiene
 - o Uses personal protective equipment (PPE)
 - o Required immunizations per Division requirements
 - Complies with Isolation precautions
