#### **Sleep Study Coordinator:**

The Sleep Study Coordinator must have equivalent qualifications, competence and function in the same role as employed individuals performing the same or similar services at the facility, as defined by facility job description.

- Assists patients with paperwork and collection of documentation
- Maintains patients files and account information
- Prepares patient room with sleep study supplies prior to patient's arrival
- Cleans patient rooms and equipment post sleep study
- Demonstrates Clinical and Service excellence behaviors to include HCA Healthcare code of conduct core fundamentals in daily interactions with patients, families, co-workers and physicians
