INVITATION FOR OFFERS TO PURCHASE THE BUSINESS AND / OR ASSETS OF DONALDSON & JAMES LTD. AND THE AGENCY EMPLOYMENT SERVICES LTD.

A process is underway to identify one or more purchasers of the business and/or assets of Donaldson & James Ltd. ("**D&J**") and The Agency Employment Services Ltd. ("**Agency**") (collectively, the "**Companies**"). The business includes all the Companies' assets, rights, undertakings and property (collectively, the "**Assets**"). The Companies, operating together, provide a range of staffing and payroll services. Agency provides temporary and permanent staffing services, primarily for light-industrial customers in the broader Kitchener-Waterloo area. D&J provides related back-office and financing services for other similar staffing agencies across Canada including Agency and unrelated, third-party staffing companies. D&J and Agency are related companies with shared management and back-office functions operating from leased premises in Kitchener, Listowel and Cambridge.



SALE SOLICITATION PROCESS

On January 23, 2019, the Companies filed Notices of Intention to make a Proposal. A. Farber & Partners Inc. was appointed as proposal trustee (the "**Proposal Trustee**"). On March 7, 2019, an Order of the Ontario Superior Court of Justice (Commercial List) was granted authorizing, the Proposal Trustee to conduct a sale solicitation process (the "**Sale Process**") in respect of the Assets.

The purpose of this invitation is to solicit interest in the Assets pursuant to the terms of the Court-approved Sale Process.
