

BHC SUCTION CANISTERS Virus Filter Efficiency

Thank you for your recent inquiry regarding Bemis Health Care's Suction Canisters virus filter efficiency, and its ability to minimize aerosolizing of the virus from the canister. We understand the increased concern most recently related to COVID-19, but at this time, we are not aware of any actual testing against the COVID-19 bacteria. However, the following information may help you with regards to Bemis Suction Canisters, and testing that has been performed.

Bemis Suction Canisters

Bemis manufactures two different lids for our canisters, each with a different shutoff mechanism.

- Bemis Hi-Flow Canisters (green lid) use a *mechanical shutoff mechanism* to shut the vacuum off when the canister is full of fluid. The cover then has a separate filter on the vacuum line to prevent contamination of the vacuum line.
- **Bemis Hydrophobic Canisters** (red lid) use a *hydrophobic media* to shut the vacuum off when the canister is full of fluid. This hydrophobic media acts as a filter, while there is a second filter in place to prevent premature shut off.

HEPA

Bemis products have not been tested against the HEPA standard, but please keep in mind that HEPA means it will need to filter out 99.97% of the particles <u>0.3 micron</u> in diameter. The HEPA standard does not evaluate the filtration of bacteria or viruses.

Bacterial Testing

Both canister types have undergone bacteria filtration testing against Staphylococcus Aureus, Escherichia Coli and Pseudomonas Aeruginosa. The Hi-Flow and Hydrophobic containers tested their filtration efficiency at 99.9998% and 99.9999%, respectively.

The bacteria tested included:

- 1. Staphylococcus Aureus: 0.1 to 0.25 micron in width by 1 to 1.5 micron in length <u>(Source:</u> Britannica)
- 2. Escherichia Coli: 1-2 micron long with radius of 0.5 micron (Source: NCBI)
- 3. Pseudomonas Aeruginosa: 0.5 to 0.8 micron by 1.5 to 3 micron (Source:NCBI)

Virus Testing

The hydrophobic filter media used in the Bemis Hydrophobic Canisters has undergone filtration testing against a representative virus (bacteriophage jX174). The tested filtration efficiency was >99.9%. The virus tested included:

1. Bacteriophage jX174: 0.017 micron (Source: Bionumbers)

COVID-19

As we all understand, many questions exist regarding COVID-19. From what we have found online, the estimated diameter of the COVID-19 bacteria is approximately <u>0.125 micron</u>. (Source: National Library of Medicine)
