

## WHAT IS THIS PRODUCT?

<b>Type</b>	The Zero Carbon Fund is an alternative investment fund under the Alternative Investment Fund Managers Directive ("AIFMD"). It is managed by us, being Sapphire Capital Partners LLP.
<b>Objectives</b>	To allow investors to aim for capital growth through investing by way of subscription for shares in relevant companies which are regarded as high risk and volatile investments. The Fund seeks to invest in early-stage companies on a mission to address climate change through technology innovation in companies that qualify for the Enterprise Investment Scheme (EIS) tax relief. The Fund will work with Zero Carbon Capital Limited ( <a href="http://www.zerocarbon.capital">www.zerocarbon.capital</a> ) to invest in teams with ideas that could scale to reduce greenhouse gas emissions by half a gigaton per year. Investor's money is spread across a portfolio of companies to help mitigate the effect of any underperforming companies.
<b>Intended retail investor</b>	The Fund is designed for private investors who understand the risks of investing in unlisted investments, typically a UK higher-rate taxpayer, over 18 years of age, normally advised by an FCA authorised adviser or a retail client that is a high net worth or sophisticated client. They may also be a professional client or an eligible counterparty. Investors should be able to lose all funds invested. An investor should have; <ul style="list-style-type: none"><li>• sufficient income tax liability to reclaim income tax relief at 30% of the amount subscribed;</li><li>• be seeking to defer a recently realised gain and/or;</li><li>• be seeking to shelter assets from inheritance tax.</li></ul>
<b>Insurance benefits</b>	The Fund does not have any insurance benefits.

## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

### Summary Risk Indicator



**The risk indicator assumes you will keep the product for seven years.** The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to cash in early. You may have to pay significant extra costs to cash in early. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as **6 out of 7**, which is **the second-highest** risk class because EIS and SEIS funds invest in early stage and growth companies which are hard to value and have a significant risk of insolvency, and where it may not be possible to quickly sell on your investment. This rates the potential losses from future performance at a **high** level, and poor market conditions are **very likely to impact the capacity** of the fund to pay you. This product does not include any protection from future market performance, so you could lose some or all of your investment. However, you may benefit from a consumer protection scheme (see the section "What happens if Sapphire Capital Partners LLP is unable to pay out"). The indicator above does not consider this protection.

## WHAT ARE THE COSTS?

### Costs Over Time

The Reduction in Yield (RIY) in the table below shows what impact the maximum total costs you might pay will have on the investment return you might get. The total costs take into account one-off, on-going and incidental costs. Typically, if applicable, they are recharged to the investee company and not payable by you. However, it is noted that performance fees are payable by you (as a deduction from the investee company sale proceeds). The amounts shown here are the cumulative costs of the product itself, for three different holding periods in the moderate performance scenario (which includes some performance fees). The figures assume you invest £10,000. The figures are estimates and may change in the future. The person selling you or advising you about this product may charge you other costs. If so, this person will provide you with information about these costs, and show you the impact that all costs will have on your investment over time.

## COMPOSITION OF COSTS?

## HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: Seven years

You need to hold this investment for at least three years in order to claim tax reliefs. As the Fund invests in early-stage companies, it will generally not be possible to cash out, sell or disinvest early. As there is no Fund maturity date, Sapphire Capital Partners LLP shall notify the Investor of the date on which the Fund will terminate which is expected to be at least seven years after the closing date of the Fund. As the return of your investment depends on the sale or other liquidity event of each portfolio company, it may be necessary to hold for longer. The net proceeds of any liquidity event for an investee company would typically be distributed to you, at the discretion of Sapphire Capital Partners LLP, within a reasonable period following that event rather than at the end of the Fund. It is not unusual for this type of investment to be held for ten years or more. You will either be unable to realise your investment early or you will have to pay high costs or make a large loss if you do so. You have 14 days from the date upon which the application form is received by the Custodian in which to cancel your investment in the Fund. You may exercise this right of cancellation in writing to Custodian and without fee or penalty.
