- 1. Call my home or cell phone and leave a message on voice mail or in person in reference to any items that assist the practice in carrying out TPO, such as appointment reminders, insurance items, normal test results and return calls requesting a call back.
- 2. At any alternative location will only leave a message on my personal voice mail or in person in reference to any item that assists the practice in carrying out TPO, such as appointment reminder calls and any calls pertaining to my clinical care. However, at any alternative location call, Jennifer Zethner and the SP Staff will not leave a message about my medical condition or lab results with any other person.
