Robotics Classroom Bundle Contest - OFFICIAL RULES

SparkFun Electronics organizes and sponsors promotions, giveaways, and contests awarding various prizes to participants. The promotions, giveaways, and contests are regulated by Contest Rules (hereinafter "Rules"). 1. PROMOTION DESCRIPTION: The Robotics Classroom Bundle Contest (\"Contest\") begins on October 15, 2019 at 12:00am MT and ends on November 12, 2019 at 11:59pm MT (the \"Promotion Period\"). The initial entry period on Twitter begins on October 15, 2019 at 12:00am MT and closes on October 29, 2019 at 11:59 pm MT (\"Entry Period\").

The sponsor of this Contest is SparkFun Electronics ("Sponsor"). By participating in the Contest, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Sponsor, which shall be final and binding in all respects. Prizes cannot be transferred, redeemed for cash or substituted by winner. Sponsor reserves the right in its sole and absolute discretion to award a substitute prize of equal or greater value if a prize described in these Official Rules is unavailable or cannot be awarded, in whole or in part, for any reason. WINNER SELECTION: Finalists of the Contest will be selected by a panel which will choose from among all eligible Entries received throughout the Entry Period, October 15 - October 29, 2019 at 11:59pm MT. The panel's choice of finalists will be conducted about 3 days after the Entry Period by Sponsor and its designated representatives, whose decisions are final. Finalists will then be voted on by the public and top five (5) entrants based upon which entrants have the most votes will be declared winners. Votes will be collected via SurveyMonkey from November 5 - November 12, 2019 at 11:59pm MT.

6. WINNER NOTIFICATION: Winners will be notified by DM on Twitter through the handle used to enter the Contest approximately 2 business days after the community vote. Potential Winner must respond to the DM to provide an email address so all relevant information can be sent to the winner and the winner's school.
