## VERMONT FEDERAL CREDIT UNION MEMBERSHIP ELECTS BOARD OF DIRECTORS AT 65<sup>th</sup> ANNUAL MEETING

Burlington, VT – On Saturday, June 2, 2018 over 250 community members joined Vermont Federal Credit Union leadership and staff at Oakledge Park in Burlington to elect the Board of Directors and celebrate the success of 2017.

The meeting began promptly at 3:30 PM with remarks from President and CEO of the Credit Union, Jean Giard and Board Chair, Joseph Finnigan. After a brief meeting, members enjoyed food from the Burger Bar, music by local singers Dwight and Nicole, face painting, balloon animals and caricature drawings.

Incumbents Megan Manahan Bliss, Suzanne Lynn and Paul Politano were reelected to the Credit Union's Board of Directors for three year terms. Incumbent Ethan Hutchin was also reelected to the Board of Directors for a one-year term.
