I 'm optimistic for our nation in this new year and decade. Why? Americans broke new records with their charitable giving last year. Early estimates are that we, as a nation, gave about \$430 *billion* in 2019. Your personal generosity was reflected in the growth of the Bradley Impact Fund in 2019: a 30% increase in funds available for charitable investments and a payout rate *five times* the national average for donoradvised funds. Thank you for believing in the impact of strategic philanthropy. Thank you for believing in your own power to make a difference in preserving, protecting, and restoring American principles and values. Please read about our community's growth as we highlight the milestones of 2019.

My optimism is about more than these numbers, though—it's what they represent. "They're uniting people in their investment in a shared outcome, whether it be achieving home ownership or gaining access to education, and the relationships they're building are real."

 JOHN BEAGLE IMPACT FUND MEMBER hen John and Gwyn Beagle attended the Bradley Impact Conference last year, they saw familiar faces from nonprofits they had been funding for years. The Beagles are active supporters of a number of charitable organizations that further education and anti-poverty goals, including Stand Together, Cross Trainers Academy, and Acts Housing. Gwyn is a lifelong science teacher and curriculum developer, having worked in a variety of environments ranging from an inner-city Milwaukee charter school to the college preparatory Brookfield Academy. John, an engineer, is the CEO and co-founder of the investment bank Grace Matthews.

The Beagles generally invest in nonprofit organizations that share their values of individual self-worth, alignment of goals among the interested parties, and a bottom-up approach to problem solving. The Bradley Impact Fund is a good fit for them.

John and Gwyn have a passion for Acts Housing in particular and the way it effectively integrates a functional housing strategy with emphasis on family relationships. Acts Housing's mission is empowerment through home ownership. Before joining the

Impact Fund, the Beagles sought out organizations like Acts Housing and Cross Trainers Academy, because they make family involvement foundational to their mission. Grant Recipient Spotlight: ELECTION INTEGRITY

hough election integrity has become a timely topic for many of us this year, for years the Bradley Impact Fund donor community and The Bradley Foundation have strategically supported organizations focused on protecting and promoting the right to vote and the American election process as defined by the Constitution. **Save Our States** concentrates on preserving the Electoral College and educating Americans about the system's role and importance in a strong democracy. **Public Interest Legal Foundation (PILF)** monitors state election law and boldly steps into the courtroom to hold state governments accountable to federal election law. In the Badger state, **Wisconsin Institute for Law & Liberty (WILL)** is defending citizens' right to vote by ensuring the Wisconsin Election Commission complies with state voter registration law. This multifaceted approach and the support the donor community provides are vital to these efforts to combat daily threats to the Constitutional order of our nation.

On Point with bradley foundation president rick graber

ilwaukee has gained significant ground for school choice in the past 30 years, and research attests to its success. Students enrolling in a private high school through the Milwaukee Parental Choice Program (MPCP) are 4-7% more likely to graduate from high school, enroll in a fouryear college, and continue with college. The values these students learn in choice schools have an impact for the rest of their lives: among 25-28 year old adults, former MPCP students committed 53% fewer drug crimes and 86% fewer property crimes than their public school peers. Despite this track record, there are new threats to education reform. Rick Graber, President of The Bradley Foundation, is a strong voice for defending and expanding school choice and providing innovative leadership in this arena.

Why is now the time to strengthen our commitment to school choice?

Study after study has shown that students in Wisconsin's school choice programs outperform their peers, not just in subjects like reading and math, but also on their path to becoming educated and informed citizens. However, school choice is being eroded at the national and state levels. We need to rejuvenate efforts to preserve the hard-won educational freedom of school choice.

What is the most effective way forward?

Through our ongoing relationships with grant recipients and the work we've done in this area for more than 30 years, The Bradley Foundation believes that today's priorities must be:

- Attracting and retaining effective teachers and school leaders
- Securing the right facilities for school choice programs to expand
- Educating and engaging parents on the choices available for their children

Our approach to support for school choice at The Bradley Foundation and the Impact Fund has consistently emphasized solutions that are local, private, voluntary, and family- and donororiented. We've seen that bottom-up solutions which empower and engage parents and root choice schools in their communities are the most effective in providing the opportunities that students need.
