Dear Friends,

SCHOOL CHOICE = HEALTHIER, HAPPIER ADULTS

It's been 27 years since Milwaukee launched the first school voucher program, sparking an education reform movement that has expanded to 26 voucher programs in 15 states and Washington, D.C. The Milwaukee Parental Choice Program represents a hard-won freedom—a fight supported by The Bradley Foundation since its birth, for parents to choose the school they want for their children.

After nearly three decades, the positive outcomes of school choice are reflected in more than just students' test scores. In the Spring 2018 issue of *Education Next*, Patrick J. Wolf, education policy professor at the University of Arkansas states:

The effects of choice programs on educational attainment—how far an individual goes in school—are both larger and more consistent than their achievement effects. Attainment is typically measured by benchmarks such as high school graduation, college enrollment, persistence in college, and college graduation. Higher levels of educational attainment are associated with a longer healthier life; higher lifetime earnings; and lower probabilities of divorce, welfare receipt, and incarceration.... It should not surprise us that private schooling boosts student attainment more than it does test scores.

Most private schools focus on educating the whole child: intellectually, behaviorally, and spiritually. For example, the Alliance for Catholic Education program based at the University of Notre Dame, which trains college graduates to teach in Catholic schools, speaks of "preparing students for college and heaven." Although research on the question

remains at a formative stage, private schools tend to focus on molding student character by fostering grit, conscientiousness, and tolerance of others. Such character traits are more predictive of educational attainment than of future educational achievement.

The attainment effects of choice programs may be outstripping their achievement effects because private schools prioritize character over test scores. That prioritization of long-term over short-term outcomes likely pleases their customers: parents.

The character- and community-building capabilities of school choice fortify the strength of America's civil society and the informed citizenship which have been at the core of The Bradley Foundation's mission since the late 1980s. The Foundation provided a small grant for the work of John Chubb and Terry Moe and their controversial 1990 book, *Politics, Markets, and America's Schools*. Foundation grants helped establish a state-level think tank, Wisconsin Policy Research Institute (now, the Badger Institute). Bradley invests in school support organizations and individual Milwaukee choice and charter schools. At the national level, Bradley has supported school choice with grants to policy and advocacy organizations.

School choice is about freedom on multiple levels, including parents' freedom to choose their children's school, and ultimately, students' freedom to develop the knowledge, skills, and strength of character to allow their dreams to become reality. The future of our nation depends on freedoms such as these.

GRANT RECIPIENT SPOTLIGHT

St Marcus School

St. Marcus Lutheran School on Milwaukee's near north side is recognized nationally as one of the city's oldest and most successful K-8 Christian urban schools. It joined the Milwaukee Parental Choice Program soon after MPCP's inception.



Today, 96% of its students attend through school choice. To best serve its students, their families and its community, St. Marcus cultivates the whole student.

The bar is set high not just for academics, but for personal growth, character development, and tight bonds with each other and the community. Ninety percent of its students go on to graduate high school and more than 50% continue with post-secondary education. St. Marcus' ability to blend solid core beliefs with an evolving approach to the needs of its congregation has made it a bedrock for its neighborhood. St. Marcus builds community, brings resources together collaboratively, and keeps its diverse student population connected 365 days a year through excellence in education and summer programs and partnerships that engage and enrich students, preparing them for the coming school year.



INVESTING IN MISSION, TALENT, AND CULTURE TO IMPROVE K-12 EDUCATION

Informed citizens with the character, habits, and knowledge to succeed in a free society are essential to a vibrant America. High-quality K–12 education helps prepare young people to advance in life with purpose and hope, respectful of the dignity of work and appreciative of the opportunities available due to America's unique political, economic, and social order.

American education is in crisis—from low-performing public schools in poor urban and rural areas, to the hyper-politicized progressive influence on America's education institutions which encourages public school students across the country to be taught from an early age to view American traditions and institutions with suspicion rather than respect. Public education monopolies are shortchanging millions of students. To counter these forces, The Bradley Foundation and the Bradley Impact Fund donor community are encouraging alternatives to K–12 public education monopolies, ensuring all parents have the freedom to choose the best school for their children.

What we see nearly thirty years into education reform is that well-run schools with a clear mission, dynamic leadership, high standards, engaging school culture, and a strong community of support invariably succeed at higher rates than standard public schools in preparing students for sustained success in life. Through this lens, philanthropic support for K–12 education is a long-term investment in schools that attract and retain high-performing school leaders and teachers committed to educating children, engaging parents and families, and partnering with the broader community to achieve common goals for children and their families. In urban Milwaukee, these elements of success come together in an array of choice and charter schools that we support, including the LUMIN Schools, Messmer Catholic Schools, Seton Catholic Schools, UCC Acosta Middle School, and Wisconsin Lutheran High School.

Given the extent of K–12 education's reach into our society, we encourage you to join us in investing in high-impact, vetted schools and school support organizations. The Bradley Impact Fund can also provide guidance as you explore opportunities to invest in individual schools, systems of schools, and/or school support organizations that advance K–12 school choice in your local community and throughout the United States.

QUALIFIED GIFTS FROM AN IRA

There's another option for your charitable giving: A required minimum disbursal (RMD) from your IRA.
