EXECUTIVE SUMMARY

The SAM Challenge

The material risk of an audit by a software publisher is significant enough to cause severe disruption to the organization and cause great strain on internal resources.

Software data is often stored in several different tools, if tracked at all. Organizations struggle to distinguish which software is deployed and where it is deployed. Identifying software deployed that is accurately mapped to entitlement rights purchased is complicated by multiple licensing models across numerous software titles.

Attempting to track this detail at the time of software request impacts your delivery speed, reducing customer satisfaction and can even lead to customer rogue buying outside of approved paths due to delays. Modern, "as a service" software has made rogue buying significantly faster and easier. Failed software audits without sufficient collateral to challenge typically leads to accepting hundreds of thousands to millions of dollars in penalties each year. Audit frequency has increased, as vendors realize that customers don't have control over software. Inability to track unauthorized and/or unsupported software titles and versions that are no longer being patched by the publisher exposes the organization.

Further, the added pressure to reduce software spend each subsequent year without the proper process or tools diminishes the ability to meet these goals.



There are 4 essential tiers of the capability blueprint to implement and mature your SAM program over time. It is not recommended to "boil the ocean" when implementing a SAM program, but rather start with Tier 1 and progress forward to the subsequent tiers based on cost and risk of audit for each software title. Evergreen SAM Smart Start will take an organization to Tier 3 on select software models.

- Tier 1 Establish Trustworthy Data: Know what you have so you can manage your assets. Having good data is the prerequisite for a successful software asset management program. This likely includes utilizing sources such as ServiceNow discovery. If the data is lacking, the program will never reach its full potential. Effort should be spent on ensuring this foundational tier is sound and accurate.
- Tier 2 Practical Management: Improve management controls and drive immediate benefits. The second tier focuses on remediating the deficiencies in Tier 1 and having a plan for tracking non-discoverable data by implementing policies and processes to effectively manage data gathering and reporting on contracts.
- Tier 3 Operational Integration: Improve efficiency and effectiveness through integration with other areas, such as Request, Procurement and IT Service Management. By integrating with existing operational business processes, SAM gains efficiencies, improved visibility, accuracy and significant time and cost savings.
- Tier 4 Strategic Conformance: Achieve best-in-class. The most advanced component which focuses on software usage, upgrades, downgrades, reclamation and retirement of software.



A 3-phased approach to delivering value consists of targeting the highest return in the shortest time that allows you to get your SAM program operational and then continuing the process as you bring more software titles into each maturity tier.
