About The Center for Children & Youth Justice

Though more than 50,000 children and youth are involved in Washington State's child welfare and juvenile justice systems every year, these systems often don't support their needs. The Center for Children & Youth Justice (CCYJ) was founded with a singular mission: to change the systems that are responsible for our state's most vulnerable young people. CCYJ is dedicated to reforming these systems so that all young people can learn, grow, and thrive, receiving every possible opportunity to succeed. It is CCYJ's goal that every child who enters these systems will be protected and nurtured, emerging better prepared to achieve their dreams, and that by making the right resources available, more children and youth will be diverted from entering these systems in the first place.

Through research, collecting data, and listening closely to children, their families, practitioners, and advocates across multiple systems, CCYJ helps identify gaps, disparities, and barriers. It shares evidence-based and proven practices, bringing together experts, policy-makers, birth and foster parents, young people, law enforcement, the courts, and communities. It develops trainings and policies that are designed to assure an environment of fair and unbiased decision-making so that systems are more equitable and more effective. CCYJ creates partnerships, and advocates for change. It fosters prevention and early intervention approaches, often enhancing coordination and collaboration across multiple jurisdictions and disciplines.

CCYJ is not a direct service provider. It works to effect reforms that are permanent, meaningful, system-wide and replicable. CCYJ leads innovation through developing pilot projects that test new ideas and interventions. Once a project is proven successful, CCYJ will find a path to embed this model for change within government agencies, the courts, law enforcement, or other organizations that should carry that work on. CCYJ then moves on to incubating the next project.

CCYJ has an extraordinary record of accomplishment in generating lasting change through the programs, practices, and laws that it has pioneered and championed in its initial years. With much more work to be done, CCYJ's Board of Directors has envisioned a strategic plan that will take advantage of CCYJ's current strengths and opportunities and expand its impact, visibility, capacity, and sustainability in the years ahead.

Long-Term Vision

Through the work of CCYJ, fewer children and youth will need to enter Washington's juvenile justice and child welfare systems. Those children and youth who are involved in the juvenile justice, child welfare and related systems will maximize their potential to become more successful and productive members of their communities. They will have the support of integrated systems staffed by highly skilled practitioners, utilizing research-based practices, in an environment of fair and unbiased decision-making.

Mission

The mission of CCYJ is to advance justice for, and enhance the lives of, children and youth through juvenile justice, child welfare, and related systems reform.

About This Position

The President/CEO, a highly successful innovator in championing and leading vital systems change, provides visionary leadership and direction for the Center for Children & Youth Justice. This inspiring leader will mobilize broad-base support to tackle systems reform by convening experts and stakeholders who can identify gaps and effect long-term change, and will be able to connect with community leaders and drive fundraising efforts. Reporting directly to a 19-member Board of Directors, the President/CEO provides subject matter expertise and resources for convening leaders and incubating innovative research, policy, training, and projects that serve as models for reform.

Responsibilities

The President/CEO will have the following primary responsibilities:

OPERATIONAL LEADERSHIP

- Provide visionary and strategic leadership, and momentum in advancing CCYJ's systems reforms and projects
- Provide expertise, inspiration, direction, and leadership for CCYJ's dedicated staff, including the executive team
- Support staff development, and maintain an environment that inspires, attracts, retains, and motivates a diverse team to further CCYJ's vision and mission
- Implement CCYJ's new strategic plan to advance the organization

FUNDRAISING

- Drive philanthropic revenue to support CCYJ's operations, growth, and vitality
- Continue to build a sustainable fundraising platform that increases unrestricted philanthropic revenues
- With an eye towards CCYJ's recently adopted Development Plan, develop sustainable, diversified revenue streams to enhance and support the organization's mission and goals
- Identify, cultivate, and solicit new sources of revenue and steward existing donors and prospects

BOARD, EXTERNAL AND STAKEHOLDER RELATIONS

- Convene and work in partnership with government officials, youth, parents, advocates, service providers, courts, law enforcement, school leaders, system professionals, and policymakers; serve as the key spokesperson for the

organization; raise awareness and enhance understanding of outcomes, disparities, and the need for reforms

- Together with staff, consultants, and the Board Communications and Marketing Committee, plan, develop, and implement a marketing and communications strategy that helps CCYJ accomplish its mission of juvenile justice, child welfare and related systems reform by inspiring, engaging and calling to action partners, supporters, volunteers, and donors
- Maintain and enhance vibrant, productive relationships with CCYJ's board, staff, and stakeholders
- Work closely with, and support, CCYJ's Advisory Council that supports CCYJ's mission
- Work closely with, and support, CCYJ's Youth Advisory Council that supports CCYJ's mission

Qualifications

The ideal candidate will possess many of the following qualifications:

- A deep and authentic passion for CCYJ's mission
- A background in working with diverse communities
- A substantial track record of leadership in juvenile justice, child welfare, mental health systems, and related systems at the federal, state, regional, and/or local levels
- Experience in achieving impact through complex systems review, assessment, and development of improved practice models and public policy, convening and leading interdisciplinary teams
- Experience evaluating (or managing evaluations of), and improving, outcomes, addressing inequity and disparities across populations and communities
- History of collaborating with agencies, service providers, lawmakers, researchers, academicians, and judicial and law enforcement personnel
- Strategic and transformational leadership known for innovation, high integrity, knowledge, expertise, and political astuteness
- Ability to develop, inspire, mentor, and lead highly committed teams
- Proven success in building productive and long-term relationships with a wide range of constituencies with an ability and/or willingness to secure philanthropic support and revenue
- Superb interpersonal, motivational, and communication skills, including strong written, verbal, and presentation skills
- A bachelor's degree (at the minimum), and preferably a juris doctorate and/or related advanced degree
