# What is PCI DSS?

PCI DSS is an international Payment Card Industry Data Security Standard created to increase security when processing card payments and reduce card fraud. Any business that accepts, processes, stores or transmits cardholder data must comply with this security standard. This baseline set of security requirements helps organisations of any size ascertain which action they should take in the event of a breach.

# How can PCI DSS help your business?
