CAREER MAKEOVER COMPETITION RULES AND REGULATIONS

Recipient will be selected from ten individuals designated by a selection committee of John Wood Community College considering objective and subjective factors. The selection process is final.

Winner will receive:

- a full scholarship or grant to attend John Wood Community College limited to tuition and fees for the winner's pre-selected degree/program.
- a waiver to cover cost of required assigned books obtained through the John Wood Community College bookstore.

Other costs, such as room and board and supplies are the winner's responsibility.

Winner is required to successfully complete the JWCC admissions/enrollment process. HS Diploma or GED is required for admission to JWCC.

Applicants are required to file for and accept state and federal financial aid that does not require repayment. (See fafsa.gov) State and federal regulations apply. Eligibility for financial aid is not required, however.

Career Makeover for programs starting fall 2018 (unless otherwise authorized).

Continuous enrollment and attendance on a full time basis is required unless otherwise approved.

Re-enrollment will not qualify for scholarship assistance.

Student must maintain good academic standing as stated in the JWCC catalog.

Winner must agree to photo/story/testimonial for JWCC/WGEM. This includes periodic updates while participating in the program.

Recipient must be at least 24 years of age as of January 1, 2018.

Programs excluded: Nursing (ADN), Medical Lab Tech, Radiology Tech, Paramedicine.

Not applicable to students currently enrolled or who have been enrolled within the last three (3) years at John Wood Community College whether full time or part time in credit courses.

Not applicable to John Wood Community College employees and their immediate family (spouse, parent, child, sibling or in-law or step-relative of similar relationship).

Completion time limit---150% of recommended program/certificate completion time. Changes or deviations from declared program are subject to approval.

CAREER MAKEOVER COMPETITION RULES AND REGULATIONS, cont'd

Maximum scholarship award of 68 credit hours.

Not transferrable or redeemable for cash value.

Selective admission programs include surgical tech and CNA.

Please note that these programs have limited number of seats per session.

Admission to the program is not guaranteed.

Winner must execute the contest prize acceptance documents.

The Process

Applications will be accepted from 12/26-1/20.

From all applications received, semifinalists will be selected and notified by January 30th.

The semi-finalist round will be February 1-2 and will include career exploration, meeting with an admissions advisor, semi-finalist interview and optional financial aid filing assistance.

Ten finalists will interview with the selection committee February 7-9 and narrowed to top three.

Winner will be announced week of February 22.

Completion of the following items by February 2 will be required to qualify as a finalist.

Help with any of these items will be available during the semi-finalist round.

2. Submit your transcripts to JWCC. (HS, GED or any college level coursework completed)
