## Affordable, reliable colocation

#### The Challenge

When you're responsible for more than 3,000 business websites, reliability is paramount. Smartz hosts and maintains those sites on their own servers, which are in turn housed in a colocation facility.

For Smartz, the customer experience has to be seamless. Outages, technical issues or downtime can cost the company customers. "We're partially a web hosting company," said Mark Knowles, CEO of Smartz. "Our customers expect speed, reliability and flexibility. If we can't deliver, it's a real problem."

When Smartz experienced reliability issues with their colocation facility, they started shopping around. "We're hosting a lot of outbound traffic," said Knowles. "We kept having problems serving up all that data and we weren't able to get them resolved. Our clients began to notice and that's when we decided to look for alternatives."

#### The OneNeck® IT Solutions Answer

Smartz soon found OneNeck IT Solutions' Tier III certified colocation facility in Bend, Oregon.

The facility features fully redundant data and power connections, along with on-site backup generators, a solar array and a passive cooling system. Its highly expandable racks feature single-and three- phase power connections with ratings from 7 kW to 21 kW. The data center is also patched in to a high-capacity fiber channel network, which is capable of providing more than enough bandwidth for hosted sites while delivering speeds up to 1 Gbps.

Additionally, the data center features 24/7 security, biometric access scanners, real-time tracking of staff and visitors and more than 50 HD closed-circuit cameras. "Businesses rely on us for their websites, so security is key," said Knowles. "The security system is phenomenal and gives us the peace of mind we need."
