- Products and services must be purchased and installed between January 1, 2018, and December 31, 2019. Rebate applications must be postmarked by December 31, 2019.
- Please submit one application form for the energy audit rebate within 30 days of the audit and one application form for the completed major measures rebate within 90 days of the completion of major measures installations or date of a blower door test, if air sealing was performed. Installation of major measures must be completed within 180 days from the date of the energy audit.
- Work must be completed by a participating contractor.
- Applicant must be a Ohio residential customer of The Illuminating Company, Ohio Edison, and Toledo Edison, FirstEnergy's Ohio utilities.
- It is the responsibility of the customer to assure that all requirements for the rebate are met. Failure to provide any of the required information will prevent processing of your application.
- Rebate payments are based on the date of service. Customers must abide by the rules and rebate levels in effect on the date of purchase.
- FirstEnergy's Ohio utilities and/or their designees including program administrators and evaluation contractors reserve the right to review installations to verify completion and measure energy savings to ensure compliance with all program requirements. Such reviews will be made at a time convenient to the applicant. Misrepresentation of installation location or measure eligibility may result in forfeiture of the rebate.
- Program procedures, requirements and rebate levels are subject to change or cancellation without notice and are subject to available program funds.
- Payment will be issued to the account holder and mailing address on record with the utility.
- Please allow up to 90 days from the date all required information is received to process your rebate(s).
- Installations must be completed in accordance with all laws, codes and other requirements applicable under federal, state and local authority.
- You are urged to seek appropriate consultation concerning any tax liabilities that could be associated with the receipt of the rebate.
- FirstEnergy's Ohio utilities and Franklin Energy, their parents, subsidiaries, employees, affiliates and agents assume no responsibility for the performance of the equipment or equipment warranty, the quality of the work, labor and/or materials supplied, and/or the acts or omissions of the participating contractor.
