
1. Call to order, roll call, and determination of quorum.

3. Public Comments – Members or visitors will be given the opportunity to address the Board with comments or concerns. Due to time constraints, public comments will be limited to three (3) minutes per speaker. No comments or action can be taken by the Board during this period. Any item requiring action will be placed on the agenda for the next Board Meeting.
4. Review and approve minutes from previous board meeting: May 4, 2020

6. Discuss and possible action: Updates from Tabor Engineering
7. Discuss and possible action on meter request made by potential West Brazos W.S.C. customer(s)
8. Discuss and possible action: Read and approve update on Consent to Encroachment and Crossing Agreement

**Public Comments:** Pursuant to the Texas Open Meetings Act and the Bylaws of West Brazos WSC, the Board reserves the right to impose reasonable limits on the number of speakers and other reasonable limitations on public comments. In accordance with the Texas Open Meetings Act, the Board will not act on, deliberate, or discuss at the meeting any public comments brought before them at this time; provided, however, that the Board may (A) make a statement of specific factual information given in response to an inquiry; (B) recite existing policy in response to an inquiry; or (C) propose to place the subject on the agenda for a subsequent Board meeting.

No final action, decision, or vote will be taken on any matter in executive/closed session.
