OUR DRINKING WATER MEETS OR EXCEEDS ALL FEDERAL (EPA) DRINKING WATER REQUIREMENTS

This report is a summary of the quality of the water that we provide to our customers. The analysis was made by using the data from the most recent U.S. Environmental Protection Agency (EPA) required tests and is presented in the attached pages. We hope this information helps you become more knowledgeable about what is in your drinking water.

Where Do We Get Our Water? - Our drinking water is obtained from Groundwater sources. It comes from the following Aquifer: TWIN MOUNTAIN-TRAVIS PEAK. A Source Water Susceptibility Assessment for your drinking water sources is currently being updated by the Texas Commission on Environmental Quality. This information describes the susceptibility and types of constituents that may come into contact with your drinking water source based on human activities and natural conditions. The information contained in the assessment allows us to focus our source water protection strategies. Water Sources - The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals, and in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water before treatment include: microbes, inorganic contaminants, pesticides, herbicides, radioactive contaminants, and organic chemical contaminants.

All drinking water may contain contaminants. When drinking water meets federal standards there may not be any health based benefits to purchasing bottled water or point of use devices. Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Secondary Constituents - Many constituents (such as calcium, sodium, or iron) which are often found in drinking water can cause taste, color, and odor problems. The taste and odor constituents are called secondary constituents and are regulated by the State of Texas, not the EPA. These constituents are not causes for health concern. Therefore, secondaries are not required to be reported in this document, but they may greatly affect the appearance and taste of your water.

SPECIAL NOTICE - Required language for ALL community public water supplies: You may be more vulnerable than the general population to certain microbial contaminants, such as Cryptosporidium, in drinking water. Infants, some elderly or immunocompromised persons such as those undergoing chemotherapy for cancer; those who have undergone organ transplants; those who are undergoing treatment with steroids; and people with HIV/AIDS or other immune system disorders can be particularly at risk from infections. You should seek advice about drinking water from your physician or health care provider. <p>Maximum Contaminant Level (MCL) The highest permissible level of a contaminant in drinking water. MCLs are set as close as possible to MCLGs as feasible using the best available technology.</p> <p>Maximum Contaminant Level Goal (MCLG) - The level contaminant in drinking water below which there is no or expected health risk. MCLGs allow a margin of safety.</p> <p>Maximum Residual Disinfectant Level (MRDL) - The highest level of disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.</p> <p>Maximum Residual Disinfectant Level Goal (MRDLG) - The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of a disinfectant to control microbial contamination.</p>	<p>Treatment Technique (TT) A required process intended to reduce the level of a contaminant in drinking water.</p> <p>Action Level (AL) - The concentration of a contaminant which, if exceeded triggers treatment or other requirements that a water system must follow.</p> <p>ppm - parts per million, or milligrams per liter (mg/l)</p> <p>ppb - parts per billion, or micrograms per liter (µg/L)</p> <p>ppt - parts per trillion, or nanograms per liter</p> <p>ppq - parts per quadrillion, or picograms per liter</p> <p>NTU - Nephelometric Turbidity Units</p> <p>MFL - million fibers per liter (a measure of asbestos)</p> <p>pCi/L - picocuries per liter (a measure of radioactivity)</p>

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Aqua is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your cold water tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. REQUIRED ADDITIONAL HEALTH INFORMATION FOR ARSENIC - Because the highest reported arsenic level on this report is between 5ppb and 10 ppb, this information is required by EPA: *"While your drinking water meets EPA's standard for arsenic, it does contain low levels of arsenic. EPA's standard balances the current understanding of arsenic's possible health effects against the costs of removing arsenic from drinking water. EPA continues to research the health effects of low levels of arsenic, which is a mineral known to cause cancer in humans at high concentrations and is linked to other health effects such as skin damage and circulatory problems."*
