

Pandemic Preparedness Checklist

Process & Procedures

Are Covid-19 updates posted on company bulletin boards? Or have they been provided via internal

communications?

- □ Have Supervisors been adequately trained on the implications of Covid-19?
- Have you given employees accurate information about ways to prevent the spread of infection?
- □ Are employees aware of the symptoms of Covid-19?

Symptoms of Covid-19:

The main symptoms to look out for are:

- Cough
- High temperature (100.4° F or greater)
- Shortness of breath
- Lost sense of smell
- Discoloration of hands and/or feet

Cleaning and Disinfecting Surfaces

Have you reviewed cleaning measures to ensure that high risk contact areas and touch points are being

regularly disinfected?

- You should ensure that public surfaces such as counters, doorknobs, handles, and light switches are regularly disinfected and create list so that items are not forgotten.
- Have you followed <u>CDC guidance</u> for cleaning & disinfecting hard surfaces as well as soft porous surfaces?
 - For disinfection, diluted household bleach solutions, alcohol solutions with at least 70% alcohol,

and most common EPA-registered household disinfectants should be effective.

- Diluted household bleach solutions can be used on hard, non-porous surfaces. Ensure proper ventilation.
- Prepare a bleach solution by mixing: 5 tablespoons (1/3rd cup) bleach per gallon of water or 4 teaspoons bleach per quart of water.
- For soft (porous) surfaces such as carpet, rugs, and drapes, remove visible contamination if present and clean with appropriate cleaners indicated for use on these surfaces.
- Do you have someone in your company that oversees cleaning/ disinfecting to verify that it is being done?
 - Create a list of cleaning supplies along with their respective locations so that you do not run out of stock and supplies can be easily replaced.
- □ Have appropriate items been laundered following <u>CDC guidance</u>?
 - If the items can be laundered, launder items in accordance with the manufacturer's instructions using the warmest appropriate water setting for the items and then dry items completely.
 - Do not shake dirty laundry; this minimize the possibility of dispersing virus through the air.
 - Clean and disinfect hampers or other carts for transporting laundry according to guidance above for hard or soft surfaces.

Employee Hygiene and Handwashing Protocol

Are staff members following the <u>CDC recommended hand washing protocol</u>?

Are staff members wearing disposable gloves and protective clothing for all tasks in the cleaning

process, including handling trash?

- Gloves and protective clothing should be removed carefully to avoid contamination of the employee and the surrounding areas. Be sure to clean hands after removing gloves.
- Cleaning staff should immediately report damage to PPE (ex: tear/ puncture in gloves) or any potential exposures to their supervisor.

Are employees following normal preventive actions while working, including washing hands and avoiding touching eyes, nose, or mouth with unwashed hands?

- Do you have hand sanitizer readily available to all employees?
- Does the Hand Sanitizer contain at least 60% alcohol?

Personal Protective Equipment (PPE) and Safety Messaging

- Do you have a policy regarding employee face covering? (disposable masks, cloth masks, balaclava, etc)
- □ Is there a plan in place to screen employees for illness as well as providing screeners the appropriate PPE?
- □ Have employees been supplied enough PPE so that they do not have to share with other employees?
- Do you have plan in place for cleaning/ disinfecting PPE? (fall protection, hard hats, eyewear, etc)
 - Is there a policy for visitors inside your facility/ on jobsites, and are you providing them the needed PPE

and/or requiring them to provide their own?

Do you need to create physical barriers between certain employee workstations or visitors/ customers

that work near one another?

Is safety messaging (signage, floor tape, etc.) needed to create safe work environment by reminding them of safety measures, company protocol?

Have you inquired about pandemic response PPE safety requirements when working at another

companies' jobsites so that you are prepared?
