E. Transfers of personal data

The request must contain and accompany the following:

- 3. The clear and precise description of the Rights that you wish to exercise; and
- 4. Any other element or document that facilitates the location of personal data.

Within a maximum period of twenty business days, counted from the date on which the corresponding request is received, we will notify you of the decision adopted. If the request is appropriate, it will be made effective within fifteen business days following the date on which we communicate the response. In the event that the information provided in your request is erroneous or insufficient, or the necessary documents are not attached to prove your identity or the corresponding legal representation, the Responsible party, within five business days following the receipt of your request, will require the rectification of the deficiencies to be able to process it. In these cases, you will have ten business days to meet the rectification requirement.

Alternatively, you may direct your request to our Personal Data Department through the email address: support@simdatagroup.com, complying with all the requirements listed above, establishing as the subject of the communication "Data protection rights" and / or revocation of consent ". The deadlines for the procedure will be the same as those mentioned in this section. The use of electronic means to exercise the aforementioned rights authorizes the Responsible to respond to the corresponding request through the same means, unless the owner himself indicates another means, clearly and expressly.

You may obtain the information or personal data requested through simple copies, electronic documents in conventional formats (Word, PDF, etc.), or through any other legitimate means that guarantees and proves the effective exercise of the requested right.

You will be responsible for keeping your personal data in possession of the Responsible updated. Therefore, you guarantee and are responsible, in any case, for the veracity, accuracy, validity and authenticity of the personal data provided, and undertake to keep them duly updated, communicating any changes to the Responsible Party.

G. Withdrawal of consent

You may revoke your consent for the processing of your personal data, without retroactive effect, in all those cases in which said revocation does not imply the impossibility of fulfilling obligations derived from a legal relationship in force between you and the Controller or implies a breach of general provisions. of public order that establish the obligation to maintain the processing of your personal data for a certain period of time.

The procedure for the revocation of consent, if applicable, will be the same as that established in the immediately preceding section for the exercise of your rights.
