Here are some resources to demonstrate how telemedicine can fit your practice's needs.

1. REDUCE YOUR NO-SHOWS AND CANCELLATIONS

Telemedicine can reduce your cancellations and missed appointments by fitting conveniently into patients' lives. A patient is less likely to be a no-show when they can do the visit in their own home. 2. IMPROVE OUTCOMES FOR YOUR CHRONIC CARE PATIENTS

Think of how much easier it is for them to do those quick check-ins and follow-up appointments via virtual visit, or use telemedicine to refill a prescription. Plus, you can quickly check-in with them on a more frequent schedule to make sure they're taking their medications properly, and spot any red flags before they become major issues.

And with [new Medicare rules](#), it's easier to be reimbursed for telehealth chronic care than ever before.

3. MAKE FREQUENT FOLLOW-UPS A PIECE OF CAKE - FOR YOU AND YOUR PATIENTS

No, not all follow-ups need to be conducted in-office. In fact, for many patients, remote check-ins are a much better option! If you work in orthopedic surgery, for example, there's no need for patients to make a long trek to your office when you could perform a post-op check via telemedicine.

11. IMPROVE YOUR PATIENT SATISFACTION AND CARE OUTCOMES

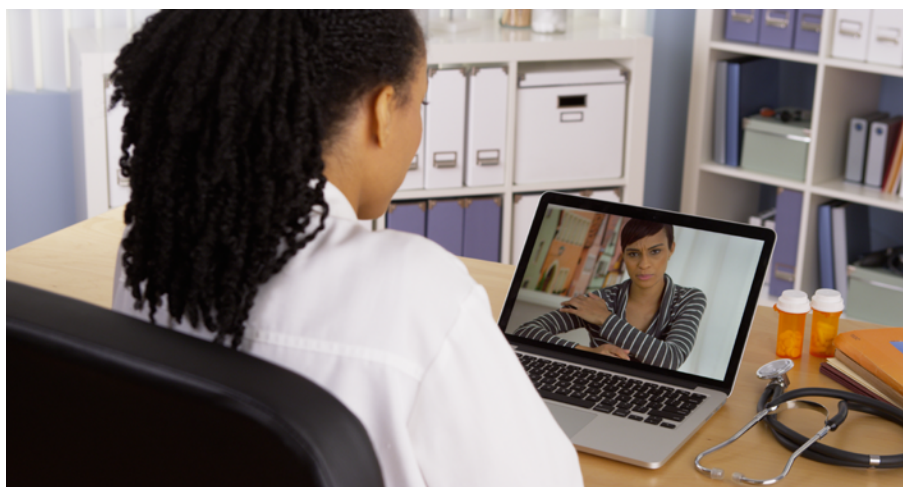
One of our favorite benefits of telemedicine is a happier patient base. Telemedicine can make running your practice easier, yes, but it also does a lot to boost patient satisfaction.

You can cut down on hospital readmissions and increase population health as a whole by implementing intelligent, impactful solutions into your network's healthcare model.





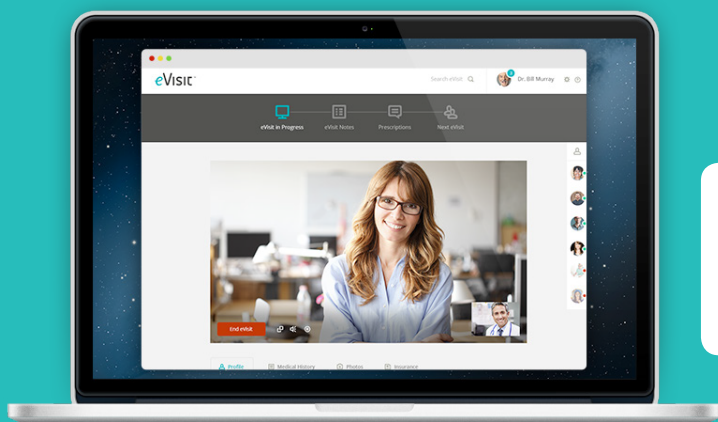
