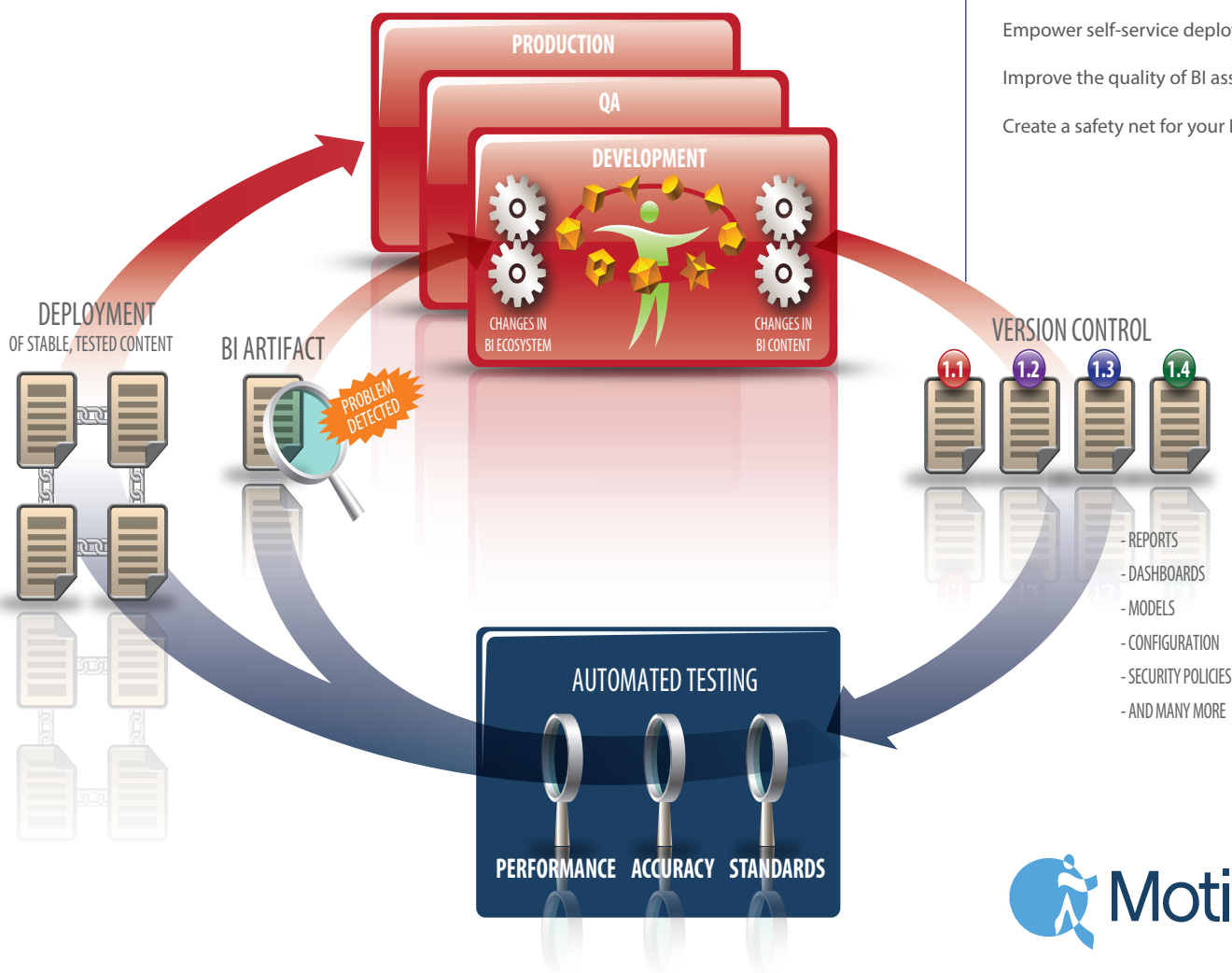

Automated Version Control

It is extremely challenging to keep track of changes occurring in BI environments. You might attempt to manage changes through excel spreadsheets, backups, or other methods that are inefficient and hard to maintain.

Automated BI Testing

Testing your BI environment requires a great deal of manual work, time, and expense. Because of this, many organizations forgo testing which is a risky choice. Some consequences of *not* monitoring and testing your BI implementation include:
