Black & Veatch Public Safety was created in 2015 through the acquisition of RCC Consultants, Inc., a nationwide consulting and engineering firm that served local government, public safety and utility wireless communication system operators. The acquisition accelerated Black & Veatch's expansion into network engineering, procurement and construction (EPC) work for public safety clients. Since then, BVPS has designed and/or implemented more than 200 wireless communications systems and more than 300 clients.
